**Mr. Rivera:** I know that DH Turf, I talked to the guy last year. I saw him do it. I talked to him and he does use a laser, doing the field. I didn't see that when I read it before and didn't see it spelled out.

**Steve Pedro:** Yes, he is. This will take care of Community Park. We did the other ones so hopefully 5, 6, 7 years, we just have to keep up on them.
