* All Memberships are **NON-REFUNDABLE, NON-TRANSFERABLE** and cannot be pro-rated or extended for ANY REASON.

* Three Month memberships must be paid in full.

* Membership card is included for new members. Replacement cards are \$5.00.

Terms and Conditions of Payments: Authorization to debit patrons' debit/credit card, checking or savings account is to remain in full force and effect until a Pass Cancellation Form is filled out online. It is the responsibility of the patron to report any and all changes made to your payment/bank information that could interfere with payments. In the event that a patron defaults on the monthly ACH payment, the Pass will be subject to suspension or cancellation with an additional Returned Payment fee applied (\$40).

- Payments will continue to be debited from accounts until a Pass Cancellation Request form is filled out.
- Debit cards, credit cards, checking or savings accounts may be used for monthly payments.
- If using a savings or checking account for monthly payments, a "VOIDED" check or bank letter with the user's account and routing number must be attached to the application form. Hand written account numbers and deposit tickets will not be accepted.
- Debit or credit card and savings or checking account payments will be taken out monthly on the purchase date. For example: If a pass is purchased on the 10th of the month, monthly payments will be charged on the 10th of every month until the pass has been cancelled.
- Any changes to the pass holders bank account, such as, but not limited to, debit/credit expiration dates, new cards, new accounts, closed accounts, ect., must be brought to the Recreation Center's attention immediately so updates can be made and there is no interference in the billing cycle. Patrons using a checking or savings account must fill out a Change of Account form and provide a new "VOIDED" check or bank statement with the user's account and routing number. Accounts are subject to a \$40 fee if accounts are not changed prior to the 15th.
- Pass holders will be notified 30 days in advance of a rate change (Change from a Youth to an Adult pass, Adult to a Senior or residency pass)
- Inactive bank accounts, bank accounts with insufficient funds, or payments that are returned for any reason will be subject to a service charge of \$40. The Pass(es) will be suspended until both the service fee and monthly payment is paid. Accounts not paid within the designated time will be cancelled and the account will be sent to the City's Finance Department for billing. Balances not paid are subject to be sent to a collections agency.
- Patrons with an outstanding balance with the Parks and Recreation Department will not be permitted to participate in any Parks and Recreation programs or use of facilities until the balance is paid in full.
- When a household's bank account has three (3) failed payment attempts, payments will need to be paid in full and checks will no longer be accepted.
- The first payment is due at the time of purchase.
- If adding members to your account, new account information is NOT needed; however, the bank account holder must be present to sign the form and must show ID.

Cancellation Policy: Recreation Center passes purchased using the ACH method of payment, authorizing a once-a-month debit from a checking or savings account, are monthly passes with no expiration date. The pass can be cancelled anytime, for any reason. A Pass Cancellation Form must be filled out and returned to the Massillon Recreation Center front desk at least 30 days prior to the next payment. A Pass Cancellation Form received less than 30 days prior to payment due date could result in a debit to your account. Recreation Center passes purchased with payment-in-full will be active for one year from the date of purchase
