### 2. Update Part Time and Seasonal staff pay schedule (Attachment)

**25-131** Mr. Hickey moved; seconded by Ms. Spencer to update the part time and seasonal staff pay schedule. Motion carried 5-0 by roll call vote.

Mr. Hickey: Just curious, how much did we up it?

**Steve Pedro:** The minimum wage is moving up to \$11 an hour. We had to change it beginning with Laborer 1. Laborer 2 is currently \$11.05-\$13.00. Laborer 2 now will be \$12.55-\$14.00 on your new sheet, there. Laborer 3 is currently \$13.05-\$15.00. It will go from \$14.05-\$15.50. Laborer 4 is currently \$15.05-\$17.00. It will go to \$15.55-\$17.00. The names you see there are Parks and Rec names of jobs. When we submit this to downtown, they get the Laborer 1, 2, 3, and 4. We put the job name as well but most importantly on the sheet that council approves is the Laborer 1, 2, 3, and 4. That's the numbers that will be on there. Every part time person is going to see a raise next year. We are trying to do the right thing and yet there are some people that have been here a while, they'll see a substantial increase. Some of the new people will start out at a higher rate as well. At the top there on your page. It should say effective 12/29/25, that's the first pay of the new year.

Mr. Rivera: Yes Steve Pedro: Okav

# 3. Replace Legends irrigation pump, not to exceed \$29,000 (Attachment)

**25-132** Mr. Hickey moved; seconded by Mr. Schartiger to approve to replace the Legends irrigation pump, not to exceed \$29,000. Motion carried 5-0 by roll call vote.

Mr. Rivera: I have a question. How many irrigation pumps do we have?

Carrie Lowry: Two

Mr. Rivera: Okay. We've gotten the first one kind of rebuilt, routine maintenance I call it. It's

going to have to happen every so many years

Carrie Lowry: Oh yeah. Steve, are they 30 years old?

**Steve Pedro:** Yes, they are the original pumps

Mr. Rivera: Okay

Steve Pedro: Last year we had the first one now this one is getting totally replaced

Mr. Hickey: That's pretty good

**Steve Pedro:** Yes. We got everything we could out of that thing

Mr. Rivera: Yes, that's great

**Steve Pedro:** Our irrigation system is doing well. There's going to be a day where we have to

replace some other things but I think we are in a good place right now

Mr. Rivera: It would be nice if it is 30 years from now

Steve Pedro: Yes, that would be wonderful

Mr. Hickey: Yes, I think so

**Steve Pedro:** Obviously we are going to accept the first bid. We always put a couple on the end in case something else should come up, a little bit more than what the price is. That's why

that is there.
