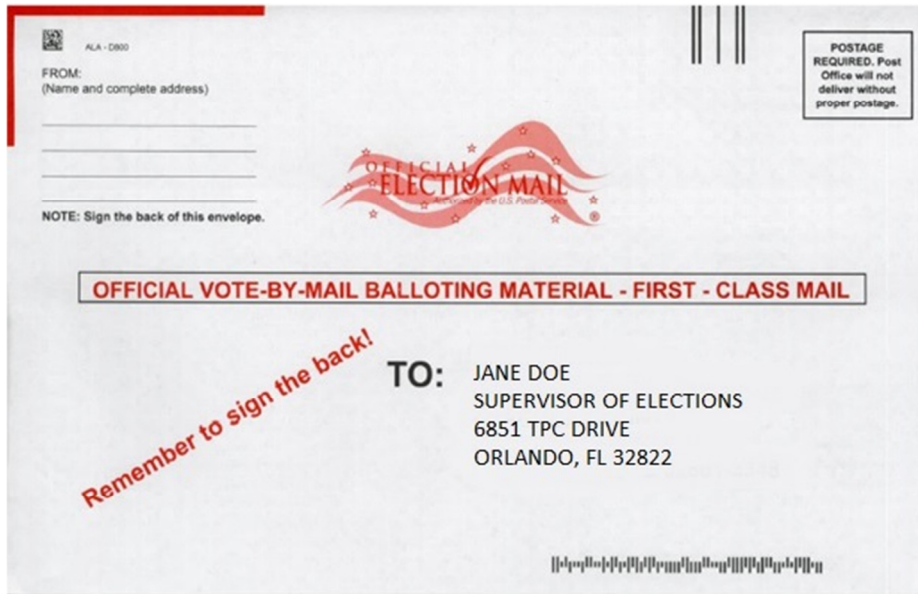
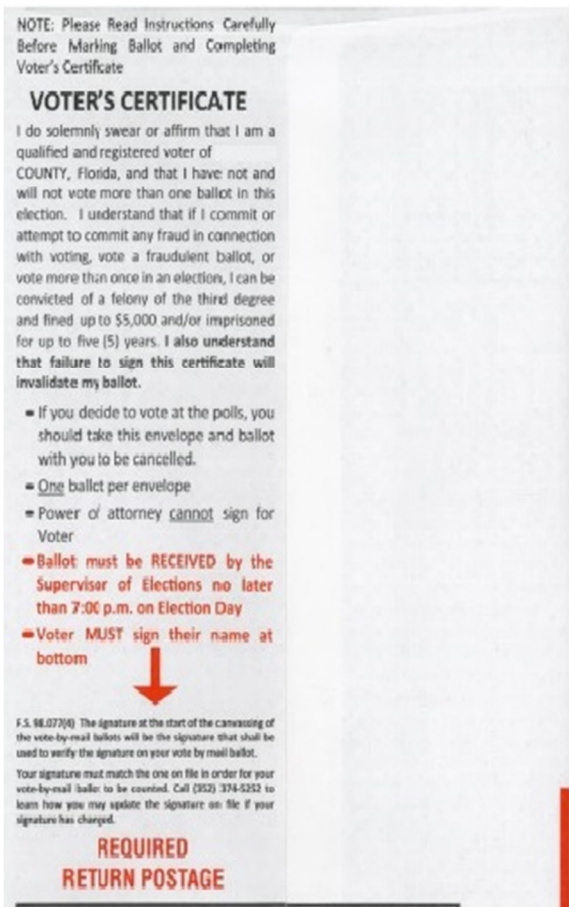


Return Envelope Front

Secrecy Sleeve

READ THESE INSTRUCTIONS CAREFULLY BEFORE MARKING YOUR BALLOT

- VERY IMPORTANT.** To help ensure your vote-by-mail ballot will count, **complete and return it** as soon as possible. Make certain it will reach the Alachua County Supervisor of Elections **NOT LATER THAN 7:00 P.M. ON THE DAY OF THE ELECTION**. If you are an overseas voter casting a ballot in a presidential preference primary or general election, your vote-by-mail ballot must be postmarked or dated no later than the date of the election and be received by the Alachua County Supervisor of Elections no later than 10 days after the date of the election.
- Mark your ballot in secret as instructed on the ballot.** You must mark your own ballot unless you are unable to do so because of blindness, disability, or inability to read or write. F.S. 101.661.
- Mark only the number of candidates or issue choices allowed (see ballot). If you are allowed to "Vote for One" candidate and you vote for more than one candidate, your vote in that race will not be counted.
- Place your marked ballot in this secrecy sleeve.
- Insert the secrecy sleeve and ballot into the enclosed mailing envelope which is addressed to the supervisor of elections.
- Seal the mailing envelope and completely fill out the Voter's Certificate on the back of the mailing envelope.
- VERY IMPORTANT.** In order for your vote-by-mail ballot to be counted, **YOU MUST SIGN YOUR NAME** on the line above "Voter Must Sign Here". A vote-by-mail ballot will be considered illegal and not be counted if the signature on the voter's certificate does not match the signature in the voter's file. The signature on file at the start of the canvass of the vote-by-mail ballots is the signature that must be used to verify your signature on the voter's certificate. If you need to update your signature for this election, send your signature update on a voter registration application to your supervisor of elections so that it is received no later than the start of the canvassing of vote-by-mail ballots, which occurs no earlier than the 15th day before election day.
- VERY IMPORTANT.** If you are an overseas voter, you must include the date you signed the Voter's Certificate on the line above "DATE" or your ballot may not be counted.
- Mail, deliver, or have delivered your ballot in the completed mailing envelope. Be sure there is sufficient postage if mailed.
- FELONY NOTICE.** It is a felony under Florida law to accept any gift, payment, or gratuity in exchange for your vote for a candidate. It is also a felony under Florida law to vote in an election using a false identity or false address, or under any other circumstance making your ballot false or fraudulent.

TO MARK YOUR BALLOT:

- Completely fill in the oval to the left of your choice as shown. Do **NOT** mark with a check or an X.



Use a blue or black ballpoint pen. Do NOT use a marker.

- If both sides of the ballot are printed, please vote both sides.
- Do **NOT** make any extra marks on the ballot.
- If you make a mistake, do **NOT** cross out or erase or use Wite-out®. Contact the election office and request a new ballot.
- Do **NOT** vote for more candidates for any one office than the number specified above the names of the candidates for that office.

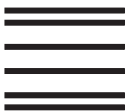

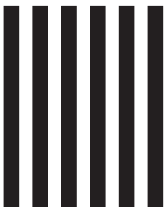
