These items will be stated in your funeral purchase contract.

PAYMENT POLICY

Payment is due upon signing of the Funeral Goods and Services Contract. The following methods of payment are accepted. Cash, Local Bank Check, and Valid Insurance Assignment processing Fee of 3%. Visa, Mastercard, Discover, and American Express all Accepted with 3% processing fee of 3%.

Our services include Conducting the arrangements conference, planning the funeral consulting with family and outside parties, preparing, and filing of necessary notices, obtaining necessary authorizations and permits, and coordinating with third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the Funeral Arrangement you select. Included but not limited to insurance, building and utility expense, equipment, furnishing and real estate taxes.

Embalming

Except in certain exceptional cases, embalming is not required by law.

- ❖ An additional weight fee of \$195.00 will be assessed from remains over 250 pounds.
- The crematory will not accept metal caskets for cremation, however the remains must be removed from the casket and placed in a durable cremation container. The casket will be destroyed if left at our facility.

State and Local Laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative Containers encase the remains and can be made of materials like fiberboard or composition material (with or without outside covering.

In the event, if the Authorizing Agent fails to pick up cremated remains or personal items of the decedent or causes them to be picked up within 60 days after completion of cremation, the facility or funeral home may dispose of the cremated remains.
