Workshop 5 -Measuring the Impact of Senate Enrolled Act 1 on Local Governments, Susan Cowan, Senior Manager -Baker Tilly - 1 CEU

To better address the budgetary pressures of the recent legislative changes in Indiana, proactive planning has become even more essential for Indiana local governments. This workshop will provide the Regional Councils with tools and strategies needed to navigate revenue constraints and build long term resilience they can use to assist the governments in their regions.

Workshop 6 - Community Development Strategies and Updates, Office of Community and Rural Affairs, Pamela Guerrero, Senior CDBG Program & Policy Analyst, Steve St. John, CDBG Program Director, and Adam Moschell, Grant Services Director - 1 CEU

This session will explore recent developments and best practices in key areas of the State Community Development Block Grant Program. Topics include updates to the Uniform Relocation Assistance and Real Property Acquisition procedures and timing considerations, insights into Resiliency Index scoring as a measure to increase resilience in rural areas and actionable steps communities can take to improve their ratings, an overview of evolving blight clearance strategies with a focus on residential impacts, and effective approaches to owner-occupied rehabilitation, including compliance with radon mitigation standards. Workshop 7 - Brownfields, Transforming Eyesores into Opportunities, Todd Relue, Partner - Kreig Devault, Cindy Taylor, Regional Manager - Atlas Technical Consultants, and John Morris, Stakeholder Engagement Coordinator - Indiana Finance Authority - 1 CEU

Indiana Communities continue to suffer the effects of properties that have been abandoned because of contamination and legal uncertainties.
