



Notably, Leiby is the author of the *Florida Construction Law Manual*, which is published by Thomson Reuters and is also available online as part of the *Westlaw Florida Practice Series*. In addition, he authored the chapters on construction liens, payment bonds,

and contracts in the ABC Contractors' Manual, which is a listed text for Florida's construction industry licensing exams.

As part of his practice, Leiby handles construction contracts, subcontracts, and other construction document drafting. For many years, Leiby handled construction litigation, but he is now occupied with mediation and arbitration. He is board certified in construction law by the Florida Bar and is also certified as a mediator by both the International Mediation Institute and the Florida Supreme Court.

Recognizing this expertise, Leiby received the 2008 Lifetime Achievement Award from the Florida Bar Construction Law Committee. He was also honored with the Excellence in Construction Education Award by the Florida Institute of Technology Construction Industry Advisory Board in 2005.
