**WEST PALM BEACH** — Who could resist spending a few minutes with someone known as The Appellate Queen?

That's what lawyer rater Chambers and Partners called Jane Kreusler-Walsh. Specifically, an appellate queen who is considered to be "the standard of excellence for professionalism" by peers.

And there was the cover story in *Super Lawyers*, which noted some of the big questions that Kreusler-Walsh has labored on. Among them, a case establishing that the reputation of a business could be considered an asset in a divorce case. And another that

confirmed punitive damage awards must be in proportion to a defendant's worth.

At last month's Athena Awards, Kreusler-Walsh's firm was honored in the business category. The award is presented to women who make a difference in the community, excel in their professions and make the time to mentor other women.
