The purpose of this policy is to ensure that Fore Resort & Spa Hotel purchases energy-efficient and environmentally friendly equipment, products, and services that are expected to have a significant impact on both energy performance and the environment.

By implementing this policy, energy consumption and greenhouse gas emissions will be reduced, while environmental and economic benefits will be increased.

Fore Resort & Spa Hotel is committed to considering energy performance as a minimum requirement in all procurement activities related to significant energy use, and to reducing energy use and greenhouse gas emissions.

Green Procurement Principles

- Minimize waste

- Maximize energy efficiency
- Maximize water efficiency

- Ensure the purchase of eco-labeled / environmentally friendly products and services
- Plan training sessions to raise awareness of sustainability opportunities in procurement processes
- Create fair trade opportunities

The Green Procurement Policy ensures that Fore Resort & Spa Hotel evaluates the impact of procurement when purchasing equipment identified as significant energy users with a potential effect on energy performance. By purchasing products and services that are more effective and energy-efficient than conventional alternatives, Fore Resort & Spa Hotel can reduce energy costs.

Procurement of energy-efficient products can not only reduce energy costs but also lower maintenance expenses, decrease greenhouse gas emissions, and improve pollution prevention and resource conservation activities.

REQUIREMENTS

Scope:

This policy covers all production and auxiliary facilities of Fore Resort & Spa Hotel, its production processes, raw material and energy consumption, all offices and office equipment/supplies, all employees, and other stakeholders (suppliers, contractors, subcontractors, and personnel included in contracts with other organizations).

Communication:

When procuring energy services, products, and equipment that have or may have a significant impact on energy use, Fore Resort & Spa Hotel will notify suppliers that procurement will be evaluated partly on the basis of energy performance.

Evaluation:

Energy use, consumption, and efficiency will be evaluated over the expected operating life of the equipment by the equipment owner or contract manager. This evaluation may rely on information provided by potential suppliers or obtained through Fore Resort & Spa Hotel's own investigations. The results of the evaluation will influence purchasing decisions.

Agreements:

Contract specifications, supplier service agreements, and similar documents will require vendors to configure equipment in accordance with the manufacturer's specifications so that it achieves optimal energy performance. Potential suppliers holding ISO 14001, ISO 50001, or equivalent certifications will be preferred. Products must also meet user requirements in terms of quality, performance, and durability. Vendors will be required to provide customer support regarding power management features to ensure proper activation and repair in case of failure.

Implementation:

Fore Resort & Spa Hotel will provide all personnel with training and awareness tools.

Fore Resort & Spa Hotel will actively encourage innovative improvements in supplier energy efficiency performance, and evidence of such communication will be recorded.

Fore Resort & Spa Hotel will continuously improve its procurement policy and guidelines by regularly reviewing contracts and suppliers, benchmarking this strategy against others, and monitoring performance indicators based on procurement standards and environmental and energy performance.

Commitment

The Board of Directors commits to fulfilling the requirements set out in this policy and expects the same commitment from all employees of Fore Resort & Spa Hotel.
