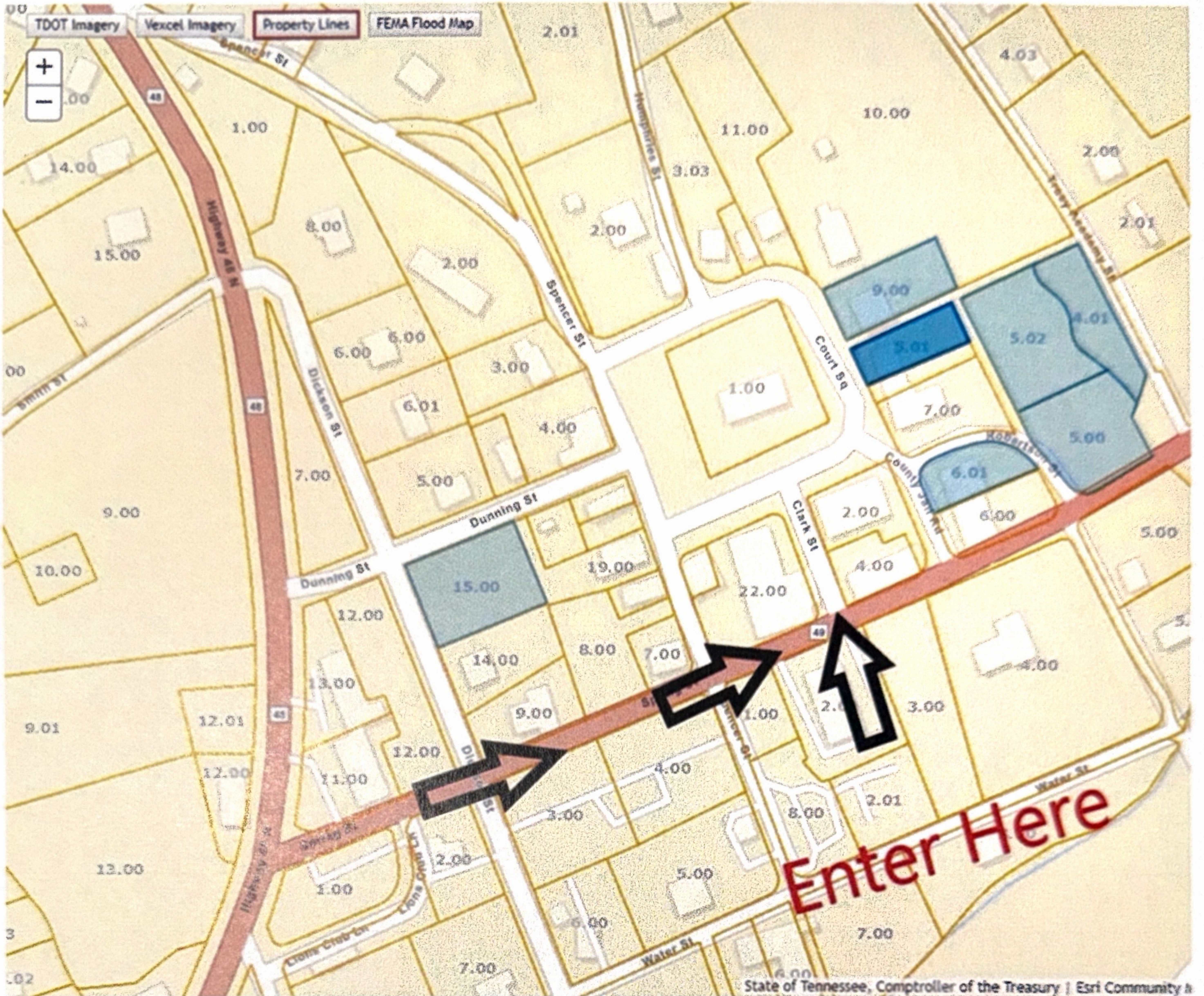
VENDOR AGREEMENT

I hereby certify that all information included in this application is correct and in compliance with all applicable rules, regulations, and requirements established by the City of Charlotte. Furthermore, I agree to abide by all City, County, and State ordinances and regulations that may apply to participation in this event. Individual liability insurance is mandatory for all vendors. The City of Charlotte is not responsible for the acts of the vendor, its employees, or agents.

Release, waiver, and assumption of risk: I, the undersigned, am fully aware and understand the potential risks involved with my participation in this event. Specific dangers include damage to personal property, loss of personal inventory, serious physical injury, or death. Additional dangers include, but are not limited to, damages due to inclement weather and other reasonably anticipated risks that accompany participation in such events. I acknowledge that I voluntarily participate in this event.
