## **Conservation Land Management Team Update**

The first stage of works at our new premises at Cameron Road, Batchelor is now complete.

The land management team have been hard at work to ensure this happened. They completed the painting of the internals of the office, undertaking garden maintenance works on the grounds and assisted in setting up the office and equipment storage. The team will have completed the move and be operating out of the new premises by the end of March.

The wet weather has hindered the ability of the team to access all locations onsite and undertake some planned work this month. Land management activities this month included:

- Assistance with Waste Rock Testing
- Weed management on mine site
- Assistance with the onsite water sampling program
- Vehicle Maintenance
- Monitoring of site access
- Seed collection and processing

## **Reconciliation Action Plan Update**

Wunun Consultancy & Business Services (Rikki McCallum) have completed work on the final draft Reconciliation Action Plan (RAP), which has now been circulated again for comment. Everyone is encouraged to have their say regarding the content of the RAP by providing feedback directly to Rikki or alternatively through the Rum Jungle Project team. We are also planning to conduct a RAP Workshop in April or May 2023, for those who wish to participate in a face to face group discussion. Once all the feedback is collated and incorporated, the RAP will be finalised and become a public document.

## **Environmental Impact Statement (EIS) Update**

The NT EPA has now completed its assessment of Projects Environmental Approval and Environmental Conditions. A copy of the assessment and conditions has been provided to both the relevant federal and state ministers for consideration to approve.

The NT EPA considers that the Project can be implemented and managed in a manner that is environmentally acceptable and therefore has recommended that environmental approval be granted.

The NT Minister approved the project's Environmental conditions, on Wednesday 29th March 2023. The Project expects to receive the federal minister's environmental approval in early April 2023.

## **Aboriginal Areas Protection Authority (AAPA) Update**

The Project requires an AAPA Certificate for areas outside of the existing certificate area onsite. The new certificates cover the roads, both borrow areas and other satellite locations. AAPA representatives have commenced fieldwork in March and will be in contact with the relevant Custodians in the coming weeks to arrange suitable times.

## **Borrow Pits Update**

The project team are continuing work with NLC on the Finniss River Aboriginal Land Trust Borrow Area "Section 19" application.

The Coomalie Community Government Council Borrow Area agreement is now complete and the Project is working with Council on the actions under that Agreement..

## **Large Major Work Packages Update**

- The Water Remediation and Pit Backfill Services package is a multi-staged procurement process that commenced in October 2022. The Early Contractor Involvement (ECI) Phase One was awarded to McMahon Services Australia (NT) Pty Ltd, Sitzler (NT) and Ventia Pty Ltd. The ECI Phase One commenced on 6 March 2023 for 13 weeks. The first interactive design session was held on 9 and 10 March 2023. All ECI Participants have collected rock and water sampling at the Rum Jungle site.
- Civil works and Site remediation services package, the Expression of Interest (Prequalification stage), is due for release in late April/early May 2023.
- Construction of Preliminary Haul Rad Section and Culvert Creek Crossing are due for release of Request for Tender in April 2023.





You need a director ID if you're an eligible officer of:

- a company, registered Australian body, or registered foreign company under the *Corporations Act* 2001 (Corporations Act)
- an Aboriginal and Torres Strait Islander corporation registered under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (CATSI Act).

Due dates to apply for CATSI Act Director ID:

| Date you became a CATSI Act director | Date you must apply |
|--------------------------------------|---------------------|
| On or before 31 October 2022         | By 30 November 2023 |
| From 1 November 2022                 | Before appointment  |
