
#### **COOMALIE ART SHOW**

#### **COUNCIL UPDATES**

#### FROM THE COUNCIL CHAMBERS

Council held its Ordinary General Meeting on 20<sup>th</sup> September 2022. And it was another busy night for Council.

The meeting commenced with two confidential presentations from external parties. From time to time, external groups need to share information or concerns with Council that cannot be open to the public and Council respects the rights and entitlements for matters to be discussed "in camera". The confidential discussions included the Local Government Association of the NT (LGANT) who needed to speak with Council regarding procedural matters and this was followed by a discussion with representatives from the Lake Bennett Community Association Inc.

- To ensure Council maintains levels of compliance and policy matters are current, a number of
  policies were reviewed by Council and ratified. All policies are publicly available on Council's
  website as required by the Local Government Act 2019.
- Policy 1.11 Rating Policy. The Rating Policy was updated to ensure procedures regarding
  Payment Plans meet with regulations and also address needs of ratepayers. All future
  Payment Plans will need to include direct debit arrangements, unless otherwise arranged. If
  ratepayers are experiencing financial hardship and are unable to meet their rates installment,
  it is a straightforward process to apply to enter into a Payment Plan with Council to assist in
  meeting rates obligations.
- Policy 1.12 Meetings of Council Policy. It has been one year since the August 2021 local government elections and Council reviewed its meeting procedures as part of its commitment to ongoing improvements and professional development. The new procedures include adopting the standard protocol of standing when speaking in the Chamber and meeting practices that support robust and professional discussion of matters. The minutes will also take on a new format, and be published to a standard in line with other local governments. Detailed reports will still be published in the agenda. All meeting agenda and minutes are available on Council's website.
- Policy 1.31 RMAC Terms of Reference. The Risk Management & Audit Committee (RMAC)

Terms of Reference were amended to confirm the level of remuneration for the Independent

Chair. To be consistent with other local governments, the Independent Chair will receive remuneration for meeting attendance commensurate with the NT Remuneration Tribunal determination for Class C1 statutory bodies. Information about the RMAC can be found on Council's website.

- In keeping with the Local Government Act 2019 Council must by 30<sup>th</sup> September each year, update the Register of Interests. This is to ensure any perceived or directs conflict of interest can be managed according to legislative and regulatory requirements. The Annual return is required to be published on Council's website.
- Council also reviewed the preliminary report from NTEC regarding the Local Government representation review. Council resolved that the current arrangements are adequate and provide effective local representation. As a result, council asked the Chief executive officer to respond to NTEC and advised that Council does not support any changes, that is, Council wants the current Ward arrangements to remain and keep the same number of Councillors.
- Council leases its premises at Finlay Road, Adelaide River to Ironbark Aboriginal Corporation. Council resolved to invite Ironbark to attend the next meeting to discuss future plans for the site with Council.
- Council received \$206,000 to upgrade or install new footpaths in Adelaide River and Batchelor. After much consideration, Council agreed that it wants all future footpaths to be constructed of concrete.
- The Pre-Cyclone Clean-Up was discussed and Council agreed that it will accept White Goods this year, either at the Batchelor waste Management facility throughout the month of October or to be collected from the verge as part of the clean-up. Council will engage a contractor to de-gas the fridges as required by regulation, prior to their recycling and/or disposal.Council also agreed to train staff members in de-gassing white goods so that future service levels to the community can be improved at reduced cost.
- The Australia Day annual event was discussed, and Council suggested next year's event take place later in the morning, as a "Big Brunch" style event, rather than a breakfast. The venue will remain as Batchelor.
- RV Friendly Town.Council endorsed proceeding with the submission for RV Friendly Town status. A preliminary review of both the facilities at Adelaide River and Batchelor took place recently. Council will need to make provision for potable water access, parking and improved signage.
- Black Spot Program 2022-23. Council has been successful in receiving funding to undertake road improvements for Haynes Road, Adelaide River and Strickland Road, Adelaide River.
- Council also awarded a tender to Territory Construction Services to undertake the constructions of a new concrete floodway on Miles Road, Eva Valley. Works will be undertaken during the first two weeks of October 2022.
- And while it seems early days, Council is required to approve the Christmas Office Closure dates and times and provide staff with adequate notice, particularly for those who are required to continue to work throughout the festive season. More information will be provided closer to the end of the year, but a note can be placed in diaries that the Administration Office will be closed from noon Friday 23<sup>rd</sup> December 2022 and re-opening Tuesday 3<sup>rd</sup> January 2023.

Members of the community are welcome to attend Council meetings! Public health safety measures still apply, particularly as there are virulent strains of influenza present in the community, in addition to the ever present concern of COVID-19. Responsible physical distancing will continue to be observed which may result in limiting numbers in the Chamber. The wearing of masks is a personal decision.

### New driver's licences for impacted Optus customers 28 September 2022

The Northern Territory Government is working with Optus to assist customers whose personal data may have been compromised.

Optus advises that the number of Northern Territory customers whose driver's licence data has been stolen is around 20,000 – all people impacted will be contacted by Optus.

NT driver's licences include two key unique identifiers (Licence and Card numbers). Both are required for the licence data to be used to conduct identity fraud. The number of customers from whom the combination of key identifying numbers were stolen is expected to be about 1% (around 200 Territorians). This number will be confirmed within the next 24 hours.

Optus will advise NT customers from whom both numbers have been stolen and strongly encourage them to apply to have their licence cancelled and re-issued.

However we understand the remaining customers who had only their licence number stolen may also be feeling concerned. If so, you are also welcome to have your licence cancelled and re-issued.

Breach notices for impacted customers will need to be presented when obtaining a new licence.

New licence fees for impacted Optus customers will be waived by the NT Government.

#### Quotes from the Minister for Infrastructure, Planning and Logistics, Eva Lawler:

"Protecting the personal details of Territorians is paramount in this case.

"The Territory Government is very aware of the anxiety this breach has created for Optus customers and we are doing what we can to help address the issue.

"We can assist through prioritising licence replacements for affected residents and waiving fees."

#### Q&As

#### I am an Optus customer - how do I know if my licence data has been stolen?

 Optus estimates approximately 20,000 NT customers have had their licence data compromised.

- The telco will be contacting customers to advise if they have had one or two identifying numbers breached.
- Customers can also check the <u>Optus website</u> for information and contact Optus via the My Optus App or call 133 937.

#### How are two identifying numbers necessary for identity fraud?

- NT driver's licences each carry two numbers: the licence number which appears on the front of your licence, and the card number, in small print on the back of the licence. The licence number is your authority to drive. The card number is unique to the physical licence that you carry.
- Both the licence number AND the card number are required for identity fraud.

#### I provided my licence number but not my card number - do I need a new licence?

- Both the licence number AND the card number are required for identity fraud. It is not necessary to seek a new licence.
- If you wish, you can contact MVR and arrange for a new card to be issued. There is no charge for Optus customers.

#### Do I have to pay for a new licence?

 Optus customers who require new licences will not be charged. <a href="https://nt.gov.au/driving/mvr-services">https://nt.gov.au/driving/mvr-services</a>


#### Do I need to attend the Motor Vehicle Registry in person to get a new licence?

 Affected customers will have to attend an MVR and present their notice from Optus. Regional and remote clients should contact the MVR on 1300 654 628 (Monday-Friday, 8am-4pm).

#### What do I need to do to protect my identity?

- All Optus customers are urged to remain vigilant and report any suspicious activity to 133 937.
- Scammers often impersonate government and businesses. Never respond to requests to provide personal and account information, or access to your device.
- Never click on any links that look suspicious or provide passwords, personal or financial information.
- Consider subscribing to <u>www.scamwatch.gov.au</u> for the latest information about scams impacting our community.
- Look out for any suspicious or unexpected activity across your online accounts and report any fraudulent activity immediately to your provider.

There is no street signage for direction to the Museum. Much of the street signage is aged and may need replacement.

Recently we held our Annual General Meeting. In preparation for reports, the visitor figures were totalled. Unfortunately there was a marked drop in visitation for this year, partly explained by the loss of scheduled visits from the Ethical Adventures tourism company who changed their schedule as a result of Berry Springs being closed until well into July. This may be a permanent change. We will be advising other operators about the Museum, the facilities and the seasonal opening hours.

Certainly tourism visitation has changed overall with the ongoing effects of the Covid shutdowns and we need to adjust to take best advantage from that. It is a fact that we have not had the visitor numbers previously in the month of September that we have had in 2021 and also in 2022.

Consequently this is reason for taking on some marketing activity. We have relied on the travellers' own websites and local promotion previously, but will take on some carefully selected advertising. Whilst our budget would not run to some of the expensive campaigns offered we will select some avenues.

Fortunately the Museum gets approval ratings from many visitors so the word of mouth avenue will continue to be of value!
