<b>Private Locker</b>	Included (two)	Private locker in our well-appointed locker rooms.

## Credit Agreement

---

1. The participant will be furnished with a monthly statement of account. Participants agree to remit payment in full within fifteen (15) days of the billing date. If the payment is received within the fifteen (15) day billing period, no finance charges will be applied.
2. Accounts where payments are received after the 15<sup>th</sup> day will be assessed a \$25.00 late fee. After 30 days 1.5% interest will be assessed. After 30 days membership will be suspended.
3. The participant to whom credit has been granted promises to pay Great River for all credit extended including any applicable finance charges. A valid credit card is required to be on file with Great River for participant on-premises charging privileges.
4. In an effort to ensure membership costs remain as low as possible; Great River recommends membership and member account payments to be made by cash or check.
5. If payment in full is not received by the fifteenth (15<sup>th</sup>) day, there will be an automatic credit card charge made on the designated card on account at Great River.
6. In the event said card is denied or cancelled a finance charge is computed by applying a monthly rate of 1.5% on the unpaid balance at the next billing date. The annual percentage rate of 18% is compounded monthly and all finance charges are for interest.
7. In the event a participant is in default of payment, Great River may declare all amounts owing to be immediately due and payable. Great River reserves the right to suspend privileges on any account in default.
8. Participants agree to pay all costs and disbursements, including attorney's fees incurred in the collection of indebtedness to Great River.
9. Applicable state and federal laws shall govern the validity of this agreement.
10. Great River reserves the right to amend this agreement and, in that event, shall notify the participant in writing.

## **Food & Beverage Minimum Policy**

---

The food and beverage minimum is \$250 per month plus tax to be utilized from April – November.

The food & beverage minimum may be applied to regular Great River and Monty's River Grille events, such as Weekly A la Carte Sunday Brunch, specialty nights, member events, our fabulous Easter and Mother's Day Brunches, and Brunch with Santa. Additional events will be designated as eligible when announced.

All food and beverage (spirits, wine, beer and soft drinks) purchased in Monty's River Grille, the snack and beverage carts or at eligible events can be used toward the minimum. Exclusions include gratuities, service charge and sales tax.

For purchases to count toward the minimum, they must be charged to your membership account. Individual members are required to have a valid credit card on file. The unused monthly minimum amount will be charged to your account on the last day of each month. Your monthly membership invoice may be paid by check or credit card per this Great River Golf Club Credit Agreement.
