A tax rate of \$0.046107 per \$100 valuation has been proposed by the governing body of **HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 80**.

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Harris County Emergency Services District No. 80 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Harris County Emergency Services District No. 80 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Harris County Emergency Services District No. 80 is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 25, 2025, AT 6:30 PM AT CROSBY FIRE STATION NO. 2, 123 S. DIAMONDHEAD BLVD., CROSBY, TEXAS 77532.

HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 80 SHALL TAKE ACTION ON THE PROPOSED RATE ON AUGUST 25, 2025, AT 6:30 PM, FOLLOWING THE HEARING TO BE HELD.

The proposed tax rate is also greater than the voter-approval tax rate. If Harris County Emergency Services District No. 80 adopts the proposed tax rate, Harris County Emergency Services District No. 80 is required to hold an election so that the voters may accept or reject the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the Harris County Emergency Services District No. 80 will be the voter-approval tax rate. The election will be held on November 5, 2025. You may contact the Harris County Clerk's Office for information about voting locations. The hours of voting on election day are 7:00 AM to 7:00 PM.
