



EVENT AND ACTIVITY RELEASE OF LIABILITY WAIVER

ALL PARTIES MUST AGREE TO THIS WAIVER TO PARTICIPATE IN ANY ACTIVITIES ORGANIZED BY BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS OR BY ITS COMPONENT FUNDS. READ CAREFULLY BEFORE SIGNING.

Acknowledgment and Assumption of Risk

I have reviewed the brief description above, as well as any promotional material of the Event, and I have personal knowledge of the activities that will be included in the Event. I recognize and understand the inherent dangers and risks, to my person and property, associated with the Event.

I also understand that the activity involves certain risks for potential injury, and that any personal protective equipment that will be provided may be inadequate to prevent serious injuries. I also understand that there are potential risks and dangers that I may not be currently aware of. Nevertheless, I voluntarily elect to participate in the above activity with full knowledge and awareness of the danger and risk involved. I hereby agree to accept and assume any and all risks of property damage, personal injury, or death.

BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS does not provide insurance to the participants of the Event or the Event activities. If I or anyone wishes to be covered for injury, death or property damage, I will need to purchase insurance from an insurer of my choice. The Organizer hereby waives any responsibility and liability to any damages and injuries resulting from this Event and from any Event activity.

Waiver of Liability and Indemnification

In consideration of being allowed to participate in the above-mentioned activity, I, and on behalf of my personal representatives, heirs, next of kin, successors and assigns, hereby forever; waives, releases, and discharges BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS, its employees, agents, officers, and contractors, the providers of any equipment used in the Activity, landowners, municipal or governmental providers of use permits, and their respective employees, officers, and directors (Herein "the Released Parties") FROM ALL LIABILITIES, CAUSES OF ACTION, CLAIMS AND DEMANDS that arise in any way from any injury, death, loss or harm that occur to me or to any other person or to any property during the Event and any Event Activity or in any way related to the Event or Event Activity, including during transportation to or from the Event or Event Activity.

This RELEASE includes claims for intentional acts and/or negligence of the Released Parties and/or claims for strict liability for abnormally dangerous activities. I also agree NOT TO SUE or make a claim against the Released Parties for death, injuries, loss, or harm that occur during the Activity or are related in any way to the Activity. Defend, indemnify, and hold harmless BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS, its employees, agents, officers, and contractors, the providers of any equipment used in the Event or Event Activity, landowners, municipal or governmental providers of use permits, and their respective employees, officers, and directors (collectively, the "Released Parties") against any and all claims, including claims for their own negligence.

I also promise to INDEMNIFY, HOLD HARMLESS AND DEFEND the Released Parties against any and all claims for my own negligence, and any other claim arising from my conduct during the Activity. In accordance with these promises, I will reimburse the Released Parties for any damages, reasonable settlements and defense costs, including attorney's fees, which they incur because of any such claims made against them. I agree that in the event of my death or disability, the terms of this agreement, including the indemnification obligation in this Section, will be binding on my estate, and my personal representative, executor, administrator, or guardian will be obligated to respect and enforce them.

Compliance with Activity Instructions, Rules, and Regulations

I agree to abide by the rules and regulations, as well as all and any instructions, provided by BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS, its staff, employees, and officers while participating in the Event or Event activities.

Independent Contractors

I acknowledge that BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS has no control over and assumes no responsibility for the actions of any independent contractors while providing any services or acting as officers for the Activity.

Severability

I agree that if any portion or provision of this agreement is found to be invalid or unenforceable, the remainder shall continue in full force and effect. I also agree that any invalid provision will be modified or partially enforced to the maximum extent permitted by law to carry out the purpose of the agreement.

Governing Law

This agreement is governed by and shall be construed in accordance with the laws of the Commonwealth of Pennsylvania.

Minors

In consideration of the minor child being permitted to participate in the Activity, I accept and agree to the full contents of this agreement. I certify that I have the authority to give permission on behalf of the minor child and to make decisions for the minor child regarding this Activity. I also agree to RELEASE, HOLD HARMLESS, INDEMNIFY AND DEFEND BLAZE ON VENTURES DBA LORAIN/STONYCREEK HIKING TRAILS from all liabilities and claims that

arise in any way from any injury, death, loss or harm that occurs to the minor child during the Activity or in any way related to the Activity. This includes any claim of the minor and any claim arising from the negligence of the Released Parties. I understand that nothing in this agreement is intended to release claims for gross negligence, intentional, or reckless misconduct, or any other liabilities that the laws of the Commonwealth of Pennsylvania does not permit to be excluded by agreement.

I HAVE FULLY READ AND UNDERSTAND THE CONTENTS OF THIS AGREEMENT AND, THAT NO ORAL REPRESENTATIONS, STATEMENTS, OR OTHER INDUCEMENTS TO PARTICIPATE IN THIS EVENT HAVE BEEN MADE APART FROM WHAT IS CONTAINED IN THIS DOCUMENT. I ALSO UNDERSTAND THIS CONTRACT AFFECTS MY LEGAL RIGHTS, AND HEREBY AM PARTICIPATING OF MY OWN FREE WILL. IF THE PARTICIPANT IS A MINOR, THE PARENT OR A RESPONSIBLE ADULT MUST BE PRESENT AT THE EVENT AND GIVE PERMISSION FOR THEM TO PARTICIPATE.

Event Cancellation Policy
