There was a quote given by Kennedy's Handyman & Remodeling for new doors. A motion was made to except the quote. All was in favor; motion was passed.


Mike made a motion to get a 2nd square reader. All was in favor; motion passed.

A motion was made to hire Jennifer Tiffany to run our social media. She will be paid 300.00 a month. All was in favor; motion was passed.


Eric Kennedy made a motion to adjourn; Mike seconded the motion. Meeting adjourned at 7:00pm.
