

Consultant: Eric made a motion to pass for the consultant services; Crystal second the motion, all was in favor of the consultant services. Motion was passed.


Eric Kennedy made a motion to adjourn; Crystal Gallo second the motion; all was in favor; meeting adjourned at 8:15.
