Consider Public Works Department Equipment Quote:

A discussion was held on needing a bucket truck or something like it to help with putting up Christmas lights. Town Administrator Cindy Stover will work with Public Works to get the quote.

Consider Wreaths Across America Donation:

A discussion was held on the Wreaths Across America Donation request that places wreaths on veteran graves during the holiday.

Recorder Charles Mason made a motion to donate \$1,700 that will purchase 100 wreaths.

Consider Change Orders for Paving Project:

Town Engineer Brad Pigott stated that the current contract expires November 15th.

A discussion was held on extending the contract time to complete the remaining work.

A discussion was then held on the details of the additional change orders and the budget.

Recorder Charles Mason made a motion to approve the change orders for paving project in the amount of \$16,150.88.

Recorder Charles Mason reminded Council to think about election coming up and that you have to sign up around the middle of January and it costs \$5 to enroll.

Treasurer John Jacobs stated that there is tree that needs cleaned up on Ruby that got cut down but is still laying there.

Mayor Jason DeFrance stated this was a good meeting and he appreciates everyone.
