 - (b) Follow our rules and instructions, including but not limited to the attached Terms and Conditions.
 - (c) Provide services from 9 a.m. to 4p.m. on the days of the Event.
 - (d) Work from the space assigned and arrive at the time you are assigned.
 - (e) Obey all laws.
- 3. You will return your assigned space in the same condition as when you arrived. Any damage to the space will be fully remedied at your expense.
- 4. You will provide the food and/or beverages listed on this Application. You will not sell or display/provide any other kinds of merchandise. We can remove any merchandise that we have not approved. We will not be responsible for safeguarding any removed merchandise.

- 5. You take all risk of loss or damage to your merchandise or other property, no matter how it is caused. You must obtain any insurance you want for your merchandise and other property. If your property is lost, stolen or damaged, you will not look to us for payment or reimbursement.
- 6. You agree to pay WFTD 15% of your Gross Sales over the 3 days of the event as outlined in the Terms & Conditions. A deposit for the assigned space will be required. This deposit will be deducted from the amount you owe from your Gross Sales. If you back out after April 1 your deposit will not be returned
- 7. Load in day is Sunday, July 12 before the start of show

Wisconsin Farm Technology Days Food Truck Terms & Conditions

DATES: July 14-16, 2026, Move-in day for Food trucks is Sunday July 12th.

Optional: To be open for sales July 13th which is main show setup day for exhibitors

SERVING HOURS: 9am – 4pm on Tuesday, Wednesday and Thursday of the event. May open earlier if vendor chooses. You MUST be open during the show hours each of the three days.

LOCATION: Redetzkes' No Joke Dairy, 216601 Wescott Ave., Stratford, WI 53503

APPLY: Applications should be submitted no later than February 1, 2026, and will be considered while space is still available. Submit the completed application form with items listed below. Incomplete applications will not be considered.

Applications may be submitted online via email to <u>info@wifarmtechdays.org</u> Preference will be given to self-contained food trucks. Electricity will be provided based on location. Refrigeration and Freezer storage are the responsibility of the individual vendor. If you need to load in prior to load in day, please contact <u>info@wifarmtechdays.org</u> to verify electrical needs will be available.

ACCEPTANCE INTO EVENT: Vendors will be notified via email or phone of confirmation into event by February 28, 2026.

PAYMENT/FEES: Fee is 15% of all gross food sales occurring at Wisconsin Farm Technology Days 2026 show grounds. A daily accounting of sales, verified by cash register documentation, must be submitted to Show Headquarters on a daily basis by 5pm. <u>Payment of full fee is due by 6pm on July 16</u>, prior to departure from show grounds. Payment can be made with cash or credit card.

SPACE ASSIGNMENTS: Booth locations will be assigned as applications are accepted. Considerations will be based on competing food categories, size of food truck, and time of submission of application. **Submitting an application does not guarantee participation**.

CHECK-IN / SET-UP: Food/Snack Vendors are required to check-in with Show Staff at Headquarters prior to setting up. Booths must be set up by 8:00 a.m. each day, open by 9:00 a.m., and remain open until 4:00 p.m. each day. Trucks cannot leave the grounds prior to 4pm on show days.

Health Department and Fire Department may inspect all food vendors prior to the event's start.

Food/Snack Vendors must be present and open for business during ALL event hours.

I am informed and acknowledge that, while participating in the sale of food at the Wisconsin Farm Technology Days location, that I am not insured by the Wisconsin Farm Technology Days for personal injuries, medical expenses, property damage or loss of any other type, including that sustained by third parties. I am further informed and acknowledge that although participating in the sale of food at the Show, I am not an employee of Wisconsin Farm Technology Days for any purpose, to include coverage under the Wisconsin Worker's Compensation statute. Inconsideration of the opportunity to participate in the sale of food at the Show, and for other valuable consideration, the receipt and adequacy of which are hereby acknowledged, I release, forever discharge and hereby hold harmless Farm Technology Days of Wisconsin, Inc. d.b.a. Wisconsin Farm Technology Days, a Wisconsin Corporation, its board of directors, volunteers, officials, agents and employees, his, her, its' or their successors and assigns and all other persons, firms or corporations who are or might be liable from any and all claims, demands, damages, costs, actions and causes of actions of whatever kind or nature which I may now have or may hereafter have, on account of, or in any way growing out of, any and all known and unknown bodily injuries, personal injuries and property damage, whether developed or undeveloped, resulting from or arising out of my participation in the sale of food during Wisconsin Farm Technology Days as outlined herein.
