THE CITY OF BEECH GROVE ORDINANCE VIOLATIONS BUREAU MUST RECEIVE YOUR RESPONSE TO THIS TICKET WITHIN **SIXTY (60) DAYS** FROM THE DATE THE TICKET WAS ISSUED. (Failure to respond within 60 days will result in the citation's transfer to the Beech Grove City Court where additional court costs will be added to the amount due.)

You may pay in person at the Beech Grove Police Department located at **103 Main Street, Beech Grove, Indiana, 46107**. Payments are accepted Monday - Friday from 9:00 am to 4:00 pm. If paying with cash, you **MUST** have exact change. Money orders and personal checks must be made payable to City of Beech Grove. **We do not accept Credit or Debit Cards**. Any request for continuance must be made in writing to the court address or email address within ten (10) business days prior to the trial date.
