

2. The following documentation must be included with your application to be considered eligible.

Nonresident Seminarian Applicants for the MDiv Program

- a. Three letters of recommendation (one from your religious superior and at least one from a former professor)
- b. *Official* college and/or graduate school transcripts; no copies will be accepted. Transcripts must be requested by the applicant from the previous institution(s) attended and sent directly to the Academic Office by the institution.
- c. Certificates of Baptism, First Holy Communion, and Confirmation, and records of any ministries (lector, acolyte) received
- d. A 3–5 page autobiography describing your familial, religious, and occupational background and previous seminary experience

Permanent Diaconate Applicants for the MATS or Certificate in Diaconal Studies Program

- a. A recommendation from the Director of the relevant deacon formation program
- b. *Official* college and/or graduate school transcripts; copies will not be accepted. Applicants must request transcripts from their previous institutions and have them sent directly to the Academic Office.
- c. A 3–5 page autobiography describing your familial, religious, and occupational background, including family support for your diaconal formation.

Lay Applicants for the MATS Program, Applicants for the MAPS Program and Nondegree, Credit-Earning Applicants

- a. Three letters of recommendation (one of which must be from your pastor)
- b. *Official* college and/or graduate school transcripts; copies will not be accepted. Applicants must request transcripts from their previous institutions and have them sent directly to the Academic Office.
- c. A 3–5 page autobiography detailing your family, religious, and work background.

3. A \$25.00 application fee is due upon receipt of the application.
4. Interviews are required for admission to any SVDP program. After completing the application, the applicant will be notified about the interview process.
