While the area will remain in the District's ownership, it will give Conservation Officers a way to enforce the laws protecting the land.

President Swanson stated that hill prairies were very special. There are some plants that will only grow in that eco system. The hill prairie at Indian Bluff is one of the few in this part of the state, and this is all about conservation and preserving nature for future generations to enjoy.
