

WHEREAS, the Annual Budget for Old Bridge Township FD No. 3 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented before the Board of Commissioners of the Fire District at its open public meeting of January 18, 2023; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,649,803.00 which includes an amount to be raised by taxation of \$2,168,480.00 and Total Appropriations of \$2,649,803.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on January 18, 2023 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 18, 2023.

THE 2023 OPERATING BUDGET IS INCREASING BY 8.8% FROM \$2,434,777 TO \$2,649,803. INCLUDED IN THE BUDGET IS INCREASE IN PER DIEM FOR ACTIVE FIREFIGHTERS AS THE VOLUNTEERS HAVE BEEN LIMITED IN THE PRIOR AND CURRENT YEARS. NO LARGE EXPENDITURES FOR VEHICLES PROJECTED FOR 2023.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

MAJORITY OF BUDGET VARIANCES ARE UNDER 10% FOR ALL APPROPRIATION CATEGORIES WHICH REFLECTS THE CONTINUATION BUDGET THAT IS PROPOSED. REVENUES FROM THE UNIFORM FIRE SAFETY ACT IS EXPECTED TO INCREASE DUE TO ADDITIONAL FIRE INSPECTIONS FOR BUSINESSES WHICH WERE CLOSED BECAUSE OF THE COVID PANDEMIC ARE NOW OPEN AND OPERATING. THE ONLY MAJOR EXPENDITURE TO INCREASE IS PAYROLL, THIS IS DIRECTLY RELATED TO THE REDUCTION IN VOLUNTEERS IN THE DISTRICT. THE PER-DIEM FIREFIGHTERS ARE REQUIRED TO FILL ADDITIONAL SHIFTS FOR THE YEAR. PROFESSIONAL FEES ARE INCREASING BECAUSE ADDITIONAL TIME IS REQUIRED TO INTERPRET STATE LAWS AND REGULATIONS ALONG WITH THE COMPLETION AND REVIEW OF THE ANNUAL AUDIT REPORT. THE SALARY AND WAGES APPROPRIATION OFFSET WITH REVENUE IS WITHIN THE 10% BUDGET VARIANCE. ON THE 2022 BUDGET FORM \$47,927 WAS MISTAKENLY BUDGETED AS SALARIES BUT SHOULD HAVE BEEN IN THE OTHER FRINGE BENEFIT LINE. THE OVERAL INCREASE IN SALARIES AND FRINGE BENEFITS IS 2.5%. THE BANK INTEREST ALSO INCREASED DUE TO THE INCREASE IN FUNDS DEPOSITED INTO THE ACCOUNTS, AND ALSO DUE TO THE INCREASE IN THE INTEREST RATES AT THE FINANCIAL INSTITUTION. IN PRIOR YEARS, WE WERE VERY CONSERVATIVE IN APPROPRIATING INTEREST INCOME BECAUSE OF POSSIBLE USE OF THE CAPITAL FUNDS TO PURCHASE APPROVED FIRE TRUCKS & EQUIPMENT. ADVERTISING IS EXPECTED TO BE REDUCED IN THE UPCOMING YEAR BY \$5,000. INSURANCE COSTS ARE PROJECTED TO INCREASE EVEN WITH THE REDUCTION OF PRESCRIPTIONS AND DENTAL CARE. MONTHLY PREMIUMS ARE INCREASING STATE WIDE.

THE AMOUNT TO BE RAISED BY TAXATION \$2,168,480 IN WITHIN AND COMPLIES WITH THE TAX LEVY CAP. UNRESTRICTED FUNDS OF \$45,437 IS 1.9% OF THE UNASSIGNED FUND BALANCE OF \$2,402,660.
