Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on January 17, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2024 and ending December 31, 2024 is hereby approved; and

THE 2024 OPERATING BUDGET IS INCREASING BY 2.3% FROM \$2,649,803 TO \$2,710,072. INCLUDED IN THE BUDGET IS INCREASE IN PER DIEM FOR ACTIVE FIREFIGHTERS AS THE VOLUNTEERS HAVE BEEN LIMITED IN THE PRIOR AND CURRENT YEARS. THERE ARE TWO ITEMS IN THE CAPITAL BUDGET THAT WILL BE \$900,000 AND ARE INCLUDED IN THE 2024 BUDGET.

MAJORITY OF BUDGET VARIANCES ARE UNDER 10% FOR ALL APPROPRIATION CATEGORIES WHICH REFLECTS THE CONTINUATION BUDGET THAT IS PROPOSED. REVENUES FROM THE UNIFORM FIRE SAFETY ACT IS EXPECTED TO INCREASE DUE TO ADDITIONAL FIRE INSPECTIONS FOR BUSINESSES WHICH WERE CLOSED BECAUSE OF THE COVID PANDEMIC ARE NOW OPEN AND OPERATING. THE ONLY MAJOR EXPENDITURE TO INCREASE IS PAYROLL, THIS IS DIRECTLY RELATED TO THE REDUCTION IN VOLUNTEERS IN THE DISTRICT. THE PER-DIEM FIREFIGHTERS ARE REQUIRED TO FILL ADDITIONAL SHIFTS FOR THE YEAR. PROFESSIONAL FEES ARE INCREASING BECAUSE ADDITIONAL TIME IS REQUIRED TO INTERPRET STATE LAWS AND REGULATIONS ALONG WITH THE COMPLETION AND REVIEW OF THE ANNUAL AUDIT REPORT. THE SALARY AND WAGES APPROPRIATION OFFSET WITH REVENUE IS WITHIN THE 10% BUDGET VARIANCE. THE OVERAL INCREASE IN SALARIES AND FRINGE BENEFITS IS 6.1%. THE BANK INTEREST ALSO INCREASED DUE TO THE INCREASE IN FUNDS DEPOSITED INTO THE ACCOUNTS, AND ALSO DUE TO THE INCREASE IN THE INTEREST RATES AT THE FINANCIAL INSTITUTION. IN 2024, THERE WILL BE A USE OF THE CAPITAL FUNDS TO PURCHASE APPROVED FIRE TRUCKS & EQUIPMENT FOR \$900,000.




