This is an Eugene MX Park form and is **not an AMA form or AMA Annual Release**.

IMPORTANT: This authorization does not replace any participant liability waiver, release, entry form, registration, identification requirement, safety rule, or other document required by Eugene MX Park or an applicable event.

I/We understand Eugene MX Park may refuse or discontinue the minor's participation for safety concerns, rule violations, failure to follow staff instructions, incomplete or unverifiable documentation, or other circumstances determined by facility/event management.
