POSITION DESCRIPTION

The Communications Fellowship will engage an emerging leader with a unique opportunity to make meaningful contributions to Allegany County, NY, while gaining experience in philanthropy and the non-profit sector. The Communications Fellow will support the Allegany County (NY) Area Foundation (CMF) in implementing communication strategies and other activities and assist the four western New York Southern Tier Foundations in their collaborative marketing efforts.

The Ralph C. Wilson, Jr. Communications Fellow will also be a member of the Rural Philanthropy Fellows cohort, which is composed of 15 fellows - 12 Ralph C. Wilson, Jr. Rural Philanthropy Fellows and 3 Herrick Foundation Philanthropy Fellows.

What You'll Receive

In honoring a healthy workplace that offers competitive salaries, benefits and a supportive working environment. For this position, the salary is \$45,000. Benefits include a professional development allowance, health insurance, life insurance, short

and long-term disability insurance, paid time off, technology allowance, and a generous holiday schedule.

What Else You Should Know

The Communications Fellow will work onsite at the Allegany County Area Foundation (Belmont, NY) office three days a week and have the flexibility to work from home (or a remote location of their choice) the remainder of the week. There will be some in-person meetings and events the Fellow will be required to attend. The Communications Fellow will also have regular connections and training opportunities as part of a cohort of Rural Philanthropy Fellows from community foundations in western NY and southeast Michigan.

ACAF is a small, growing foundation and this position offers the right candidate exposure to all aspects of running a community foundation.

RESPONSIBILITIES

What You'll Do

- Skills and experience: Strong written and verbal communication skills; project management; familiarity with social media, experience with graphic design, photography and videography will be helpful.
- Characteristics: Mature, detail-oriented; teachable; proactive; consistent internal communicator; creative problem solver; flexible; organized; able to manage multiple projects; reliable and able to meet deadlines; interest in non-profit work.
- Abilities: Works well on a team, and independently; works positively with a variety
 of personality types; comfortable interacting with a diversity of people and
 cultures and demographics (from high schoolers to senior citizens).
- Able to protect confidential information and avoid conflicts of interest.
- Willingness to travel within the state and regionally, and potentially nationally to attend meetings and conferences.
- Ability to represent ACAF positively to peers, other foundations, and the public.
- Proficiency in Microsoft PowerPoint, Word, Excel, and Outlook,
- Proficiency with Adobe products, videography, and/or podcasting is a plus.

Through grant support made by the Ralph C. Wilson, Jr. Foundation and the Herrick Foundation, the Fellows will support and be employed by the community foundations to support their rural-focused efforts.
