The Cemetery Clerk presented the report, which included a quarterly finance update and information about the number of remaining plots at Ings Lane Cemetery. The report now includes the numbers of new burial and ashes plots used on a month-by-month basis, from 2017 to date. This data will continue to be reported on a quarterly basis.

Despite consulting with Waltham residents via posters, website, social media and Parish Office drop ins, only 92 forms were completed, with the following results.

Q1. 75% of Waltham residents are in favour of going ahead with the new cemetery.

Q2 57% of Waltham residents do not support the proposed council tax precept increase for the purpose of loan repayments.

The Cemetery Committee want to ensure that as many Waltham residents can have their say and complete the survey.

**RESOLVED:** That the Cemetery Committee recommend to Full Council the same survey be run again in the summer edition of the Waltham Newsletter alongside a full article on the proposals and run pop-up stands during the consultation period of the survey.

Data showing new plots sold will be included within the quarterly report. As previously acknowledged, it is difficult to predict new plot sales for the year as these have fluctuated along with funeral figures but assist with predicting the lifespan of the current cemetery.

### 4. Remaining Full and Ashes Burial Plots

<b>Ashes Plots</b> Section H	No plots available in this section, aside from reservations.
Section I	Row F in section I is now a mix of full and ashes burials. This is to make it easier to manage plot allocation and minimise additional maintenance work. Ashes plots are allocated from the path side and full plots are allocated from the shrubbery side of the section.
<b>Full Burial Plots</b> Section I	There are 81 full burial plots remaining within Section I although some of these will be used as ashes plots.

### 5. General Updates

- Grave Ownership – the family seeking to transfer the ownership of the Exclusive Rights of Burial for a grave for their late great aunt has decided not to proceed due to the documentary requirements for this legal process. A file note has been made, should the family seek to proceed later.
- The Tidy up session held on Monday 9<sup>th</sup> March 2026 saw the two Clerks, several Parish Councillors and WIB volunteers collect a waste bin full of dying memorial flowers and rubbish from the cemetery ahead of Mothering Sunday in just over an hour.  
Thank you to all of those who attended, your help and support is greatly appreciated.
- There is some work needed to update the map in Section I, to redraw plots due some of the full plots being allocated as ashes plots.
- I am looking at creating some simple guides for Exclusive Right of Burial owners to give greater understanding of what this ownership means and the rights are, which will be issued to new owners.

Good Afternoon, Amanda,

The WIB group met this morning, and we would like to put the following proposal to the cemetery committee:

We propose the Parish Council review their policy on items which are allowed to be placed on graves. i.e. not allowing plastic or silk flowers, toys, ornaments, and any other non- biodegradable items to be placed on graves. Only fresh flowers should be allowed on graves.

This will prevent damage to maintenance machinery, stop the accumulation of non-biodegradable, dirty litter, and maintain a uniform, respectable appearance.
