6. Receive monthly report from Treasurer and consider:

- (a) approval of payment of monthly bills and invoices:

Commissioners approved \$11,900 for the annual radio contract/\$72 annual renewal of our Post Office box/\$4999.99 for repairs to the brush truck/\$209.69 Gexa/\$9,272.50 to YRWD for the annual audit/Z. Zett made a motion to approve up to \$5,000 to purchase 2 desktop and 2 laptop computers for the fire station. G. Penny seconded. Motion passed unanimously.

R. Davis made motion to approve financials. Z. Zett seconded. Motion passed unanimously.

- (b) approval of monthly financial report

R. Davis made motion to approve financial report as presented. Z. Zett seconded. Motion passed unanimously.

7. Receive monthly report from Palmer fire department personnel regarding emergency operations, response times, call volume, training, equipment, apparatus, and fire station, and take any related action:

Chief Medina reported that there were 38 calls: 8 MVA/1 structure fire/5 vehicle/4 grass/12 EMS and 8 Misc. Volunteers had already responded to 13 as of 3/10.

P. Burns asked how the volunteers were doing overall because of the high number of fatalities they had responded to. Chief Medina said he had reached out to Matt Bullard with Balch Springs who was a grief counselor. Chief said M. Bullard had come to speak with the volunteer and volunteers greatly appreciated his presentation and time. G. Penny made motion to send Mr. Bullard \$250 for his services. R. Davis seconded. Motion passed unanimously.

Chief Medina also announced that he is working on the WEX card and looking into a training grant from the FFA. He said the one brush truck has been repaired and that the \$4,999.99 for the second brush truck was to repair a blown head gasket.

Chief Medina announced that the Annual Fish Fry would take place on June 14th; Open Burn training is scheduled for March 29th; and that Hose Testing would be conducted April 21st on the Methodist Church parking lot.
