1. Canvass returns of the November 4, 2025, election;

2. Adopt an Order Canvassing the Returns and Declaring the Results of Ellis County Emergency Services District No. 9's November 4, 2025, Election; and

P. Burns then read the Certificate for Order Canvassing the Returns into the record. P. Burns stated that there was a total of 730 voters who voted in the overall elections. For the ESD's Sales Tax Election issue, there were 714 total votes cast with 360 votes FOR and 354 votes AGAINST. The Proposition passed.
