The Challenge

Scenario 1: Private Sector – Investment Banking Organisation Undergoing a Major Outsource and Transformation

Consider a global investment banking organisation engaged in a large-scale outsourcing and transformation programme that transfers 50 percent of its IT estate

to a strategic partner. The arrangement involves novating more than 3,000 third-party supplier contracts, establishing a new retained organisation, implementing a new governance framework, and introducing a revised operating model.

As part of this transition, new operational, staffing, and transformation budgets are defined. However, as delivery progresses, multiple issues emerge. Unexpected integration costs arise due to incomplete scoping of legacy systems. Supplier billing lacks transparency, resulting in overlapping charges across service towers covering Wintel, Unix, Data Centre Facilities, Provisioning, and other services.

The transformation budget becomes unstable. Cost forecasting is inconsistent, interdependencies between delivery and retained functions are overlooked, and material financial risks emerge. The cumulative effect is a breakdown in cost control, escalating spend, and growing uncertainty regarding financial exposure. Internal teams attempt to correct the situation but lack the cross-domain expertise to isolate root causes, reconcile financial inconsistencies, and re-establish budgetary control.

A Budget Management Troubleshooter is required to intervene. By combining financial management capability with programme delivery and operational insight, the Troubleshooter diagnoses the financial governance breakdown, redefines budget ownership, implements effective tracking and reporting mechanisms, and realigns financial plans with actual delivery realities. The outcome is restored cost control, transparency, and confidence in both programme and financial governance.

Scenario 2: Public Sector – Central Government Department Managing Multiple Digital Transformation Programmes

Consider a central government department delivering a portfolio of digital transformation and change programmes in parallel. Each programme has different timeframes and objectives: one focuses on digital infrastructure, another on citizen service modernisation, and another on internal process automation.

While each initiative operates independently, they are linked by shared resources, overlapping dependencies, and budget interrelationships. For instance, one initiative reduces staff travel to achieve cost savings, yet this creates a surge in demand for local office space and video conferencing infrastructure. Another reduces supplier headcount to streamline costs, but the resulting service gap must be filled temporarily through consultancy expenditure.

These cascading dependencies create a three-dimensional budgetary landscape where each decision impacts multiple other areas. Without cohesive oversight, the department faces cost overruns, conflicting priorities, and an increasing inability to manage or explain budget variances. Internal governance teams, though skilled, are unable to integrate budget control across such diverse, interrelated programmes while maintaining delivery pace.

A Budget Management Troubleshooter in this scenario provides the coherence and alignment needed to restore control. Acting across strategic, operational, and financial dimensions, the Troubleshooter identifies interdependencies, reconciles
