### The Challenge

#### Scenario 1: Private Sector – Global Investment Banking Organisation Undertaking a Major Outsource and Transformation

Consider a global investment bank with a highly fragmented software and infrastructure landscape, supported by several thousand suppliers and vendors. Many vendors hold multiple contracts across different divisions, each with unique pricing, contractual terms, and service conditions.

The organisation is undertaking a major outsourcing programme involving the transfer of 50 percent of its IT estate to a strategic partner. More than half of its third-party suppliers, associated staff, and contracts are being novated as part of the transition. At the same time, the commercial management team is being reduced to a single retained resource, leaving a critical gap in control and oversight.

During the outsource, it becomes evident that planned OPEX and CAPEX budgets are inadequate by almost 80 percent. Immediate cost rationalisation and compliance remediation are required to achieve the projected savings and maintain financial viability.

The organisation, however, lacks an internal software licence compliance function and has no comprehensive view of its software estate, contractual obligations, or vendor dependencies.

A Software Licence Compliance Troubleshooter becomes essential. The Troubleshooter conducts a full analysis of the existing software environment, identifies cost inefficiencies and compliance risks, harmonises overlapping or inconsistent contracts, and designs a rationalised licensing model aligned with the new outsource structure.

#### Scenario 2: Public Sector – Central Government Department Merging Two Executive Agencies

Consider a central government department mandated to merge two executive agencies within twelve months. The merger includes consolidating people, processes, and technologies, and achieving a 75 percent reduction in duplication across systems, applications, and licences. Each agency currently operates its own software procurement, licensing, and governance structures, supported by different suppliers, audit regimes, and commercial terms.

The integration creates a complex challenge. Licensing overlaps are widespread, vendor pricing structures are inconsistent, and several critical applications are supported under conflicting contractual arrangements. Furthermore, interdependencies between transformation projects mean that licensing issues in one area have cascading impacts on cost, compliance, and service delivery in others.

The absence of cohesive licence compliance governance leads to escalating costs, duplicate licensing, spend and heightened audit exposure. Without coordinated oversight, the department risks breaching vendor agreements and failing to meet mandated cost reduction targets.

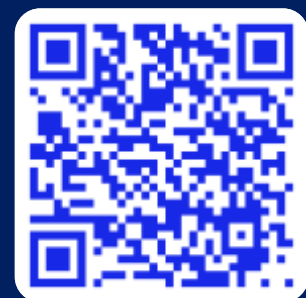
