◆ **BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF** \$2,990.00

Our charge includes consultation with the family or responsible party; staff and facilities to respond to initial requests for service; coordinating service plans with cemetery; securing official documents and necessary registrations and sheltering of the deceased. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

◆ EMBALMING \$810.

Embalming of a Tissue Donor and/or Autopsied Body \$960.

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Kansas 65-1734. Order of priority of persons authorized to dispose of decedent's remains; immunity of funeral directors, funeral establishments and crematories. (a) The following persons, in order of priority stated, may order any lawful manner of final disposition of a decedent's remains including burial, cremation, entombment or anatomical donation:

- (1) The agent for health care decisions established by a durable power of attorney for health care decisions pursuant to K.S.A. 58-625 et seq., and amendments thereto, if such power of attorney conveys to the agent the authority to make decisions concerning disposition of the decedent's remains;
- (2) the spouse of the decedent;
- (3) the decedent's surviving adult children. If there is more than one adult child, any adult child who confirms in writing the notification of all other adult children, may direct the manner of disposition unless the funeral establishment or crematory authority receives written objection to the manner of disposition from another adult child;
- (4) the decedent's surviving parents;
- (5) the persons in the next degree of kinship under the laws of descent and distribution to inherit the estate of the decedent. If there is more than one person of the same degree, any person of that degree may direct the manner of disposition;
- (6) a guardian of the person of the decedent at the time of such person's death;
- (7) the personal representative of the decedent; or
- (8) in the case of indigents or any other individuals whose final disposition is the responsibility of the state or county, the public official charged with arranging the final disposition pursuant to K.S.A. 22a-215, and amendments thereto.

CREMATION WITHOUT A SERVICE (Direct Cremation) \$4,320.

Our charge for direct cremation without any attendant rites or ceremonies includes basic services of funeral director and staff, local transfer of remains to funeral home, care of remains, transfer to crematory and customary cremation fees. State and local laws do not require a casket for cremation. If you want to arrange a direct cremation, you can use an alternate container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering).

Direct cremation with alternative container (Opaque Shroud) \$4,320.

Direct cremation with casket or alternative container supplied by purchaser (this price PLUS the price of selected container) \$4,285.

FORWARDING REMAINS TO ANOTHER FUNERAL HOME**\$4000.**

Our charge for this service includes basic services of funeral director and staff, transfer of remains to funeral home, embalming, shipping container required by airlines and transportation to airport. This charge does not include viewing, ceremony or airline shipping charges.

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME**\$3,495.**

Our charge for this service includes basic services of funeral director and staff, transfer of remains to the funeral home, and casket coach (hearse) for local transportation to local cemetery or crematory. This charge does not include visitation, rites or ceremonies.

IMMEDIATE BURIAL

Our charges for an immediate burial, without any attendant rites or ceremonies, includes removal, washing and disinfecting, shelter of remains, local transportation to the cemetery, necessary services of staff and authorizations. This charge does not include visitation, rites, ceremonies or merchandise.

Payment Policy

Our funeral home is a small business and like many others in our community, out of necessity, we operate on a cash basis, relying upon the families we serve for prompt payment. We do not have sufficient financial resources to extend credit over a period of months or years, nor does law allow us to fulfill the functions of a bank or other lending institution. Therefore, payment is expected at time of arrangements and due prior to services rendered.
