A 5% service fee will be added if paying by credit or debit card.

Shipped semen orders must be submitted by 10:00 AM.


Snow Ridge Farm or stallion owners shall not be liable for any injury, disease or death resulting from breeding or boarding. Snow Ridge Farm reserves the right to reject any equine deemed physically unfit and to administer veterinary testing or medical attention as necessary. All charges for boarded horses – including veterinary, blacksmith, and board fees – are due within 30 days of billing. Stud fees are due when the mare produces a live foal or upon change of ownership, whichever occurs first. All balances must be settle before the equine is removed from Snow Ridge Farm. Overdue accounts will incur a late fee of 2% per month.
