Justin Weimer made a motion to approve Resolution No. 25-2501 a resolution expressing support of the City of Lockwood's application for fund through MoDOT's transportation alternatives program and authorizing the submission of an application relating to the proposed Lockwood Route 160 sidewalk improvements project. Perry Ellis seconded the motion. Motion carried by roll call vote 4-0.
- E. Neal Sands ask Isaac to get an updated cost on putting new restrooms at Smith Park.
- F. Neal Sands made a motion to pay city bills. Steve Fyfe seconded the motion. Motion carried by roll call vote 4-0.

- A. Mayor Schilling said that she thought the new metal banners looked nice. She asked the aldermen if they thought we should go ahead and order some for the holidays. Some discussion was had about holiday banners, but no decision was made. Mayor Schilling said she had called DNR about raw sewage being let out on the ground at a local resident and was waiting to hear back from them.
- B. Golf course greenskeeper, Perry Finley, was not present.
- C. City superintendent, Isaac Dodd said he would have the pad mounts for Ag Service and Frickenschmidts next week. He told the council that his crew had been sweeping streets with the new skid steer.
- D. City clerk Joy Finley said she thought the city needed to investigate having businesses pay for these expensive pad mounts like other cities do. The alderman asks her to coordinate with Phil Greathouse about finding out how other local cities do that.
- E. Phil Greathouse, city attorney, was not present. Blake was present but had nothing.
- F. Alderman Steve Fyfe said he thought buying a new mower for the golf course would be a better plan than buying a used one. There was discussion about hiring a person to keep the city restrooms clean all summer. Justin Weimer had pictures of a 2-wheel drive pickup for Roger Stone. Isaac said it would not work because Roger needed a 4-wheel drive to get in and out of the lagoon area.
