Disclosures/Agreement

1. **REQUIRED:** I understand that I am responsible for obtaining the following:
 - a. Proof of liability coverage **COI** (required by GAFF & venue)
 - b. Health permits required from ALL food vendors for effective event dates, including all out-of-state food trucks and food vendors

 - c. Fire permits required from ALL food trucks
 - d. Any other necessary documentation to participate in the event as communicated by GAFF
 - e. Must post "Sales Tax Included in Price" in the vendor booth/space, where applicable.
2. I understand I will complete a NV Department of Taxation Sales Tax Form and once completed, submit directly to GAFF Logistics Team at the end of Sunday evening or NV Department of Taxation. (KEEP IN MIND - List of vendors is submitted to NV Department of Taxation)
3. **POWER:** Food Trucks/Booths will be supplied with up to 50 amps of power through open hours of the event weekend (at least 4 hours prior). Business Booths will be provided with up to 20 amps of power one hour before and through open hours of the event. Additional power requirements need to be specified. Additional fees will apply
4. **EXCLUSIVITY:** Food vendors may **NOT** sell the following items unless approved by Great American Foodie Fest:
 - a. Lemonade (or any lemonade mixes/blends)
 - b. Agua Frescas
 - c. Funnel cake
 - d. Any alcoholic drinks (including beer and wine)
5. **LIGHTING:** Lighting will **NOT** be included (Must bring your own or rent from us by completing the application (Additional costs will be applied to any items rented on the day of the event, if available)

6. Vendor spaces will be determined by order submission of application & fees paid in full (First come, first served basis!)
7. Food vendors are limited to a 20% markup on all food items. We have received too many complaints about food vendors marking up their prices too high which in turn adversely affects the patron's experience.
8. I understand that Great American Foodie Fest reserves the right as final authority in all decisions related to the Great American Foodie Fest. Details are subject to change upon the discretion of Great American Foodie Fest.
9. All vendors must supply Great American Foodie Fest with the size/dimensions of their Food Truck to ensure proper layout spacing of the event PRIOR to when vendor placement begins.

NOTE: Any mandate changes imposed by local, state and/or federal government, including SNHD (Health Department) and Fire Department, which affect the occupancy of this event will cause this event to be cancelled/postponed. All payments received will be credited to the next scheduled event. If you should not comply, you will no longer be invited to any Great American Foodie Fest events.

10. **SUBJECT TO FINE:** All vendors must be open and ready for serving the patrons when the event gates open as mandated by the Great American Foodie Fest. There have been several incidents when vendors are not open at the time of event start and gates open.
 - **No exceptions: If any business vendor spot is found not open there will be a \$100 fine.**
 - **No exceptions: If any food truck or food booth vendor is found not open there will be a \$250 fine.**
11. **\$200 CLEANING MAINTENANCE, & EQUIPMENT FINE:** This is to notify you that if you leave your space messy, there will be an additional \$200 Cleaning Fine charged due to the excessive trash and damage left to the property of various stains including oil stains and trash left behind after the event. Some examples of reasons you will charge a vendor fee:
 - a. Excessive trash left in your area
 - b. This includes the proper use of grease traps AND grey water tanks provided throughout the lot and near the commissary area.
 - c. Please take the necessary precautions to keep your areas clean and not cause any damage to the property as we have received numerous complaints from the property

- d. Leaving event before it ends and not completing your participation. **NO EXCEPTIONS**
- e. **RETURN OF GAFF EQUIPMENT:** \$100 for any vendor:
 - Taking chairs, tables, lights, sidewalls or any items not belonging to you or your co.
 - Causing any damage to equipment or event site (may incur additional cost depending on damage caused)

NOTE: Please make the necessary arrangements to ensure you're **ALL** operating and ready to serve at the time gates open, as this will also affect returning to any future events. If you should not comply you will no longer be invited to any Great American Foodie Fest.

VENDOR PLACEMENT:

*We will begin vendor placements approximately 3 weeks before event start. We will be texting/ calling each vendor based on a **pecking order on when full payment was made**. If you do not respond in a timely manner, we will move on to the next vendor until you contact us with your placement selection.*
