



Thornley Dance Academy: Terms and Conditions of Enrolment

1. General Information

1.1 These Terms and Conditions apply to all students who enrol at Thornley Dance Academy.

1.2 By enrolling at Thornley Dance Academy, you agree to abide by these Terms and Conditions and any policies or rules provided by the Academy.

2. Enrolment and Payment

2.1 Enrolment is complete only when the Academy receives the completed registration form and a signed copy of the terms and conditions set out below.

2.2 Fees are payable in advance for each month as per the payment plan agreed upon at the time of enrolment as stated on the 'Welcome Letter'.

2.3 All payments must be made by the specified due date on the monthly invoice to ensure continued participation in classes. Thornley Dance Academy reserves the right to cancel or suspend enrolment if payment is not received by the specified due date each month.

2.4 Fees are non-refundable unless Thornley Dance Academy cancels a class.

2.5 If the student misses a class for any reason, the student will not be entitled to a refund or reduction in tuition fees. The only exception to this is if the student is seriously ill or can provide evidence of admission to hospital.

3. Attendance and Conduct

3.1 Students are expected to attend classes regularly and arrive on time.

3.2 In the event of illness or absence, students should inform the Academy as soon as possible.

3.3 Students must respect Thornley Dance Academy's rules and regulations, including but not limited to maintaining appropriate conduct and attire, as specified by the Academy's staff.

3.4 Disruptive behaviour or failure to follow the Academy's rules may result in dismissal from classes without a refund.

4. Health and Safety

4.1 All students must ensure they are in good health and capable of participating in dance classes.

4.2 Students must inform the Academy of any pre-existing medical conditions or injuries that may affect their ability to participate fully in classes on their enrolment form prior to commencing classes.

4.3 Thornley Dance Academy will take all reasonable steps to ensure the safety of students during classes, but is not responsible for accidents or injuries that occur due to non-compliance with instructions or failure to disclose relevant health information.

4.4 Students must wear the appropriate footwear and clothing for each class as specified by the Academy.

5. Uniform Requirement

5.1 All students attending dance classes at Thornley Dance Academy are required to wear the designated uniform for their specific dance style. This ensures a professional environment and enhances the learning experience.

5.2 All students who enrol to Thornley Dance Academy are required to have purchased or ordered the core uniform items required for classes within 6 weeks of attending the academy.

5.3 Only the approved uniform for each class must be worn. The uniform list includes dance shoes, leotards, tights, and other accessories as specified by the academy. Any variations or non-approved attire will not be permitted.

5.4 All uniforms should be of the correct size and fit for comfort and safety. Loose or ill-fitting clothing may hinder performance and could be a safety hazard.

5.5 Students must maintain the cleanliness and good condition of their uniform. Torn, stained, or damaged attire should be replaced promptly to maintain a neat appearance.

5.6 Students are expected to arrive at class fully dressed in their uniform. This includes appropriate footwear and attire as specified by the academy, ready to begin class on time.

5.7 In cases of medical or personal circumstances, students must inform the academy in advance if they are unable to wear the full uniform. A valid reason will be required, and an alternative arrangement may be made.

5.8 All dancewear that is ordered from Thornley Dance Academy must be paid in full prior to collection. Please see our uniform purchase policy for further details.

6. Photography and Filming

6.1 Thornley Dance Academy may take photographs or video recordings during classes or events for promotional or educational purposes.

6.2 By enrolling at Thornley Dance Academy, students or their guardians grant the Academy permission to use such photographs and videos for marketing and promotional materials, unless otherwise stated on the enrolment form at the time of enrolment.

7. Cancellation and Withdrawal

7.1 If a student wishes to withdraw from a class, written notice must be given to Thornley Dance Academy via letter or email at least 7 days before the start of the next month. Failure to do so may result in a charge for the following month. Students wishing to leave Thornley Dance Academy will not be refunded fees for any unused classes.

7.2 In the event of serious illness or injury, the Academy may offer a partial refund or credit, at its discretion, providing that the student can supply a valid medical certificate.

7.3 Thornley Dance Academy reserves the right to cancel any class due to insufficient enrolment or other unforeseen circumstances. In such cases, a full refund will be issued.

7.4 Any outstanding fees remaining must be paid for prior to termination of classes.

8. Limitation of Liability

8.1 Thornley Dance Academy accepts no liability for personal property that is lost, damaged, or stolen while attending classes or events.

8.2 Thornley Dance Academy is not liable for any personal injury sustained during class participation, except where caused by the Academy's negligence or failure to follow health and safety guidelines.

9. Changes to Terms and Conditions

9.1 Thornley Dance Academy reserves the right to amend these Terms and Conditions at any time. Students will be notified of any significant changes in writing or via the Academy's website and social media pages.

10. Governing Law

10.1 These Terms and Conditions are governed by the laws of the United Kingdom, and any disputes will be subject to the exclusive jurisdiction of the courts in the United Kingdom.
