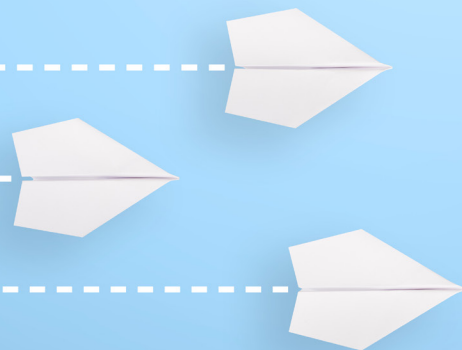

Responsibilities

- Respond promptly to calls from Funeral Directors alerting you a death has occurred.
- Ensure transfer vehicles are equipped with the necessary supplies and equipment.
- Provide any family present with assurance and information about next steps.
- Follow proper identification procedures to ensure secure chain of custody.
- Safely complete transfer back to the Funeral Home using company vehicles.
- Follow established check-in procedures upon return.
- Place decedent in climate-controlled room at Funeral Home.
