

## BUENA VISTA COUNTY FAIR 2026 INFORMATION &amp; CAMPING RULES FOR 2026

Failure to comply with the following rules and regulations may result in eviction from the campgrounds.

- Each campsite reservation needs to be paid in full at the Buena Vista County Fairboard by Thursday, June 25 to guarantee reservation.
- Each campsite must be registered.
- No excessive noise, which may disturb other campers, will be permitted.
- **Quiet time is from 11:00 PM to 6:00 AM. Children should be at their campsite by 11 PM or accompanied by an adult if using restrooms.**
- Parents must accompany small children when using restroom facilities.
- Camp visitors must vacate campgrounds by 11:00 p.m. During fair hours, **visitors must park in general fair parking.**
- Campground speed limits for all roads within the campground is five (5) mph.
- Please drive carefully and watch for children and pedestrians.
- **Only 1 vehicle allowed per spot in the campground area.** All other vehicles to be parked in the south hay ground parking lot. No Parking around the Horse Arena.
- Kids' battery powered vehicles, bikes, scooters, etc. are not allowed outside of the campground area for safety purposes.
- Only Fair Board members and ISU Extension staff are allowed to use motorized vehicles.
- You can have a tent on your campsite for an extra cost of \$4.00 for children & \$11.00 for adults.
- Please drink legally, responsibly and keep your consumption limited to your campsite.
- Smoking is not allowed in any fairground building.
- Campfires are allowed only when contained within fire rings.
- Buena Vista Fairgrounds are not responsible for personal items that are lost or stolen or any damage to your camper, vehicles, or any personal belongings. Please make sure you have secured your personal belongings.
- No drainage water or sewage may be disposed of on the surface of the ground. If caught, you will be asked to leave the Campgrounds and will not be permitted to return the following year. THIS INCLUDES "GRAY WATER."
- Help us keep B.V. Fairgrounds clean by placing all garbage in provided dumpsters.
- We do not offer refunds for early departures after Check IN.
- All pets must be on a leash at all times. Electric fences and electronic collars are not sufficient means of leashing. Pets must be confined or on a leash 6 feet or less in length. Unattended pets are subject to immediate removal and impoundment. With the exception of service animals, pets are not allowed in bathrooms or shower buildings and pet waste must be picked up and properly disposed. Do not attach pet leashes, ropes, chains, clothes lines, etc. to trees or shrubs.
- Washing of campers and vehicles using campground facilities is strictly prohibited.
- Swimming pools are not allowed in the campground.
- The use of fireworks, firearms, explosives, and weapons is prohibited.
- Spraying of any type of chemical is NOT allowed.
- NOTE: The length and width of each campsite is limited to the area marked. This is the only space to which you are entitled.
- Violation of any rule may be reason for revocation of all Campgrounds permits, and immediate, on the spot expulsion from the grounds for the remainder of the Fair without refund.
