GENERAL PRICE LIST

These prices are effective April 1, 2026 but are subject to change without notice.

The Federal Trade Commission (FTC), the New York State Department of Health and the New York City Department of Consumer Affairs require funeral providers to make certain disclosures on the General Price List. Although these disclosures are similar, they are not exactly the same.

This General Price List contains the required disclosures by the FTC, the NYS Department of Health and the New York City Department of Consumer Affairs. The disclosures required by the FTC, when different from those required by the Department of Health and Consumer Affairs, are preceded by the letters “FTC.”

(FTC)

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery services, flowers, and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

Your authorization is required for a funeral home to obtain custody of a body, and a body must be released promptly upon request.

The provider of funeral services is required to give price information in person and over the telephone.

A provider of funeral services is prohibited from representing that the deterioration of human remains can be prevented from more than a limited time by embalming, caskets, vaults, or outer interment receptacles.

Alternative Services:

The following charges for direct burial and cremation **do not** include additional items or services, merchandise, facility use, and livery that the customer may wish to select.

Both Direct Cremations and Burials are the disposition of remains without any attendant rites or ceremonies and scheduled at the convenience of the funeral home.

Direct Cremations

Prices range from \$1,395.00

Which includes the local transfer of remains to the funeral home, staff services, securing of necessary authorizations, basic local transportation to the crematory, an alternative container for cremation, and the return of the cremains to the funeral home.

To \$1,195.00

Which includes the services as described above but with the cremation container supplied by the customer.

The direct cremation prices do not include crematory charges and cash advances.

(FTC)

If you wish to arrange a direct cremation, you can use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without and outside covering) or may be pouches of canvas or other materials.

Direct (Immediate) Burials

Prices range from \$2,700.00

Which includes the local transfer of remains to the funeral home, the services of the funeral director and staff, securing of necessary authorizations, basic local transportation to the cemetery, and an alternative container.

To \$2,650.00

Which includes the services as described above but with the alternative container supplied by the customer.

The direct burial prices do not include cemetery charges and cash advances.

(FTC)

Our charge for an Immediate Burial (without ceremony) includes Basic services of funeral director and staff, a proportionate share of overhead costs; removal of remains; local transportation to cemetery.

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.

It is our funeral home policy that decedents who have passed from COVID-19 or other contagious-related illnesses must be embalmed for any service related to identification or visitation.

It is the policy of this firm that no family members are permitted in the preparation room.

(FTC)

Except in certain special cases embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial.

Other Preparation (Excluding Embalming):

Preparation of the remains, unless selected, is not required for direct cremation or direct burial.

- a. Topical Disinfection \$250.00
- b. Custodial Care (charged after **24** hours) charge per **day** \$100.00
(Custodial care will not be charged on the days when embalming or other preparation of remains occurs, visitation is held, or a funeral service is conducted.)
- c. Dressing / Casketing \$200.00
- d. Cosmetology (Female / Male) \$80.00
- e. Hairdresser / Barber \$150.00
- f. Restoration (per hour) \$100.00
- g. Refrigeration (per day) \$100.00
(Refrigeration will be charged when no embalming is to be performed)
- h. Topical Disinfection & Dressing for ID \$350.00

Arrangements & Supervision

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains, or receiving of remains because the prices of those services include this charge.

(FTC)
This fee for sour basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving of remains.

(Transportation beyond local point of shipment will be billed either as livery or common carrier charges depending upon the forwarding location. Local point of shipment is up to or within the 5 boroughs.)

With Embalming \$3,810.00

Receiving Remains from another Funeral Home..... \$2,735.00

This charge includes the basic local transportation of the remains to either the funeral home or place of local disposition, staff services, and securing necessary authorizations. The charge does not include additional items or services, merchandise, facility use, and livery that the customer may wish to select.

(Transportation beyond local point of shipment will be billed as livery charges. Local place of disposition is up to or within the 5 boroughs.)

Cash Advances

Services and merchandise provided as cash advance items will be billed at the same amount paid by the funeral firm. We charge no more for these services than the actual cost.
