

## Equipment Oahu 9th Island Sweepstakes

### OFFICIAL RULES

The Equipment Oahu Ninth Island Sweepstakes (the "Promotion" is sponsored by Equipment Oahu LLC (the "Main Sponsor").

How To Enter:

There are three (3) ways to enter the Promotion to receive "Entry Points":

1. Online Entry. Starting at 12:00 p.m. HST on 7 January, 2026 and ending at 7:59 p.m. HST on 7 March 2026, visit [equipmentoahu.com/con/agg-2026](http://equipmentoahu.com/con/agg-2026), locate the Promotion entry form, and complete all required information and follow all posted instructions to register and receive three (3) Entry Points in the Promotion.
