



## Corporations

Since 2006, Arizona corporations have been invited to partner with STOs to provide much needed tax credit scholarships to qualified private school students. At first, only C corps and insurance companies that collected premiums were included in the law. Now, S corps and flow-through LLCs are potential partners.

- Is your company a corporation?
- Do you have a liability to the State of Arizona of at least \$5,000?
- Would you like to make a donation toward private school scholarships through the corporate tax credit? Corporate tax credit donations begin at \$5000. Each year, the State of Arizona limits the total amount of corporate state tax funding that can be used for distribution to private schools. White Mountain Tuition Support Foundation (WMTSF) is an independent, non-profit School Tuition Organization (STO) created in 2000 to accept tax credit donations for private school scholarships (A.R.S. Section 43-1089 and ARS 43-1089.03). Individuals still have two tax credits to take advantage of for 2025-2026 and your limits are slightly higher. And now, Arizona corporations can take a separate Low-Income Corporate Tax Credit. See the back of this brochure for more information!

(By law, a donor must first donate the maximum Original Individual Tax Credit before he/she can claim the PLUS Tax Credit. However, you may send just one check for both).

- ✓ 92% of St. Anthony's students in kindergarten through 8th grade qualified for and received tax credit scholarships in 2024-25 (17 St. Anthony Students received ESA funds).

### Just follow these steps:

Look for the line titled **"Balance of tax"** on your state tax return to see how much your tax liability for the state is for 2025. This is the amount you can **REDIRECT** to scholarships..

### There are two other ways to take the tax credit:

1. Write just one check for both credits and mail it to **WMTSF, P.O. Box 2047, Lakeside, AZ 85929** with this form to the right, **OR...**
2. Charge your credit card by calling **928-521-3826**.

**Notice:** A school tuition organization cannot award, restrict or reserve scholarships solely on the basis of donor recommendations. A taxpayer may not claim a tax credit if the taxpayer agrees to swap donations with another taxpayer to benefit either taxpayer's own dependent.
