KINDERGARTEN REGISTRATION

Ferron Elementary will be registering Kindergarten students for the 2026-2027 school year. Registration will be held **Monday, March 2, 2026 from 8:30-9:30.** Students need to be five years old on or before **September 1, 2026** to register. Please bring an **original** birth certificate and immunization record. For more information, you may contact the school at 384-2383.

To attend Kindergarten, a student **MUST** have proof of the following immunizations:

- 5 DTP/DTaP/DT – 4 doses if 4th dose was given on/after the 4th birthday
- 4 Polio – 3 doses if 3rd dose was given on/after the 4th birthday
- 2 Measles, Mumps, Rubella (MMR)
- 3 Hepatitis B
- 2 Hepatitis A
- 2 Varicella (Chicken pox)

Proof of immunity to disease(s) can be accepted in place of vaccination only if a document from a healthcare provider stating the student previously contracted the disease is presented to the school.

To receive a vaccination exemption form, the legally responsible individual who claims the exemption for the student must complete the online immunization education module. To access the online immunization education module, go to immunize.utah.gov. If the legally responsible individual who claims the exemption for the student declines to take the online education module, he/she can obtain a vaccination exemption form from a local health department and receive an in-person consultation.
