November 7, 2025	Applications are closed. • Late submissions will not be accepted
November 2025- January 2026	Application reviews, funding recommendations & decisions will be completed by our Community Investment Committee and Board of Directors
February 2026	Applicants will be notified of funding decision
April 1st, 2026	Funding begins





ELIGIBILITY CRITERIA

To be eligible to receive United Way funding, community service organizations should meet the following criteria:

- Be incorporated and registered as a charity.
- Deliver a funded program or initiative that does not unnecessarily duplicate existing services in the community.
- Have a volunteer Board of Directors.
- Release audited financial statements annually.
- Have been in operation for at least two years.
- Align with United Way Sault Ste. Marie & Algoma District's focus areas, goals and strategic directions.
- Demonstrate how the program or initiative will contribute to achieving the specified goals and connected strategic directions.
- Clearly outline how they will achieve positive outcomes for the people they serve.
- Articulate the methods they will use to evaluate and measure these outcomes.
- Collaborate with other local organizations in innovative ways to leverage services and better meet community needs.
- Provide a realistic budget that demonstrates the need for funding from United Way Sault Ste. Marie & Algoma District.
- Enter into a formal "Funded Partner Agreement" with United Way Sault Ste. Marie & Algoma District.





INELIGIBLIE ORGANIZATIONS

The following organizations are ineligible for funding:

- For-Profit Entities: Organizations primarily aimed at profit generation.
- Unions and Professional Associations: Groups representing labor or professional interests.
- Individuals: Funding is not available for personal applications.
- Foundations: Funding only for direct charitable programs, not annual disbursements to other donees.
- Political Organizations: Entities focused solely on political activities.
- Discriminatory Organizations: Groups operating in a manner deemed discriminatory under the Ontario Human Rights Code.
- Religious Organizations: Those whose activities involve direct religious worship unless they also provide community services clearly stated in their bylaws.
- Duplicate Service Providers: Organizations providing unnecessary duplicate services in the community.
- Organizations Lacking Transparency: Groups without clear governance structures or financial accountability.

ELIGIBLE EXPENSES

Eligible Program Expenses:

Eligible expenses include reasonable expenses that are directly related to the program, to further the project's purpose and activities, including:

Program Costs: Expenses directly related to the implementation of funded programs or initiatives, such as:

- Staff salaries and benefits for those working directly on the program.
- Supplies and materials necessary for program delivery.
- Contracted services for specialized expertise (e.g., facilitators or trainers).

Operational Costs: Limited operational expenses that are directly associated with the program, including:

- Rent and utilities for space used by the program.
- Equipment necessary for program delivery (if not considered capital expenses).
- Communication and outreach costs to promote the program.
- Evaluation and Reporting: Expenses associated with assessing the program's effectiveness and outcomes, such as:
- Tools and resources for collecting data and evaluating impact.
- Reporting costs for submitting evaluation findings to United Way.

Training and Development: Costs related to training staff and volunteers involved in program delivery, including:

 Workshops, seminars, or courses that enhance skills relevant to the funded program.

Community Engagement: Expenses for initiatives that build community partnerships or involve community members in the program, including:

Events or activities that engage the community in program activities



INELIGIBLE EXPENSES

Ineligible Program Expenses

Ineligible expenses include but may not be limited to the following:

- Fundraising events or conferences.
- Films or videos that do not support or are not essential to the program
- Programs/services operating outside Sault Ste. Marie & Algoma District
- Programs/services not aligned to our impact area.
- Program/services that could be deemed discriminatory, as defined by the Ontario Human Rights Code.
- Deficit or emergency funding, or contingencies.
- The principle portion of mortgage payments or depreciation of buildings and equipment.
- Capital campaigns or large capital expenditures exceeding \$3,000 (Note: small capital expenditures of essential program equipment are eligible).
- Religious activities.
- Partisan political activities as defined by Canada Revenue Agency.
- General operating funds for the purpose of organizational stability.
- Interest expenses.
- Legal penalties.





APPLICATION EVALUATION

All applications from eligible organizations will be reviewed and all applicants will receive notification of the outcome of the application. Unfortunately, not all organizations or applications can be funded and some may not be funded at the level requested.

All applications are reviewed and evaluated by our Community Investment Committee. This dedicated volunteer committee consists of community members who bring a wealth of firsthand experience, a deep understanding of local needs, and valuable insights into both prevalent issues and the non-profit sector. Their diverse backgrounds and expertise ensure a thorough and thoughtful assessment of each application. Following their evaluation, recommendations are presented to and approved by our Board of Directors

In general, funding applications will be evaluated on the following criteria:

- Alignment of the proposed program outcomes with the outcomes of United Way's impact areas.
- Demonstrated need for the program/services in our local community
- Activities, timelines and budget reflect a sound program design and is within the capacity of the organization to implement and oversee
- Intended impact on our community both from an outcome perspective and that the community will be (or has been) meaningfully involved in the program design and delivery.
- An equity lens has been applied and where applicable, there is evidence the organization has experience working with the population it intends to serve
- Diversity of income sources (we encourage a variety of income sources to assist with your financial sustainability).

Sault Ste. Marie & Algoma District



All organizations who are successful in receiving funding will be required to complete reporting at both the middle and end of the funding term. Reports will include qualitative and quantitative questions, including a budget submission outlining how the funds where used.

• Failure to submit reports may impact the release of funding for the subsequent year or future funding applications.
