**AGREEMENT TO AMEND THE AMENDED AND SUBSTITUTED
DECLARATION OF COVENANTS OF RESTRICTION**

(Filed on January 24, 1988, Recorded in Book 267, Page 221)

The following amendment was duly passed pursuant to the provisions of Article XIV, Section 2, of the Amended and Substituted Declaration of Covenants of Restriction after written notice of the proposed change was sent to every owner at least ninety days in advance of the action taken, which was on January 30, 2011.

Article XI, Restrictions on the Use of the Land, is amended by striking the first unnumbered paragraph under Section 1 (Residential Use) and, in its place, putting the following:

Lots 1 through 21 of The Green Fifth Addition shall be known, described, and used solely as single-family residential lots. Each lot in the properties is hereby restricted to residential use and uses related to the convenience and enjoyment of such residential use. In no event shall more than two (2) unrelated persons occupy, use, purchase, own, rent, or live in any of the homes, garages, or townhouses as now located on said premises or Properties, or which may hereafter be built for the purpose of residential use.

Unnumbered paragraphs 2 and 3 of Section 1 remain the same.
