Storage:				
Once we have finished loading your storage unit for you, we no longer take responsibly for any of the items that are in the storage unit. If we are unloading your storage unit, we are only responsible for the items that are in our immediate care.

On loads and unloads, we are only there for half of the move, (loading or unloading). If we are loading or unloading a truck or vehicle for you, we are only responsible for the items that are in our immediate care.  Initial				
Absent Customer:				
We encourage our customers to be with us throughout the entire move. Whenever we move a piece of furniture we like to be able to point out any scratches, marks, or dings that you may not have noticed. If for some reason you are not able to be there for your move or if you need to leave in the middle of the move, we need you to sign this release accepting all of the items in the condition that we bring them to you. We will not be responsible for any missing items, or damaged items. We will not be responsible for any of your items that were not moved.    Initial

If we feel that your particle board item has a high chance of getting damaged due to weakness, flaws or instability it will be necessary to have it disassembled. If you would like Simple Moves to take it apart or to move it as a whole, you will need to sign this release.  Initial

From time to time if we feel we can connect or disconnect one or more of your items safely, we would be happy to do so.
