You may choose only the items that you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. (This fee is already in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

This list does not include prices for certain items you may ask us to buy for you, such as cemetery services, flowers, and newspaper notices. The prices for those items will be shown on your bill or the statement of funeral goods and services selected.

Our charge for this service includes Basic service of our funeral director and staff, transfer of remains to funeral home from airport, and refiling fees. This charge does not include, viewing, ceremony, funeral hearse, shipping container, casket, international documentation fee, or airline shipping charges.

DIRECT CREMATION: \$1,995 to \$8,590

A “Direct Cremation” is a disposition of human remains by cremation without viewing/visitation, rites or ceremony. The expense for direct cremation includes: Basic services of funeral director and staff, local transfer of remains to funeral home, care of remains, refrigeration of unembalmed remains, Cremation fee, and returning cremated remains to family.

Payment Policy

Our funeral home is a small business and like many others in our community, out of necessity, we operate on a cash basis, relying upon the families we serve for prompt payment. We do not have sufficient financial resources to extend credit over a period of months or years, nor does law allow us to fulfill the functions of a bank or other lending institution. Therefore, payment is expected at time of arrangements and due 48 hours prior to services rendered. If payment is not received in full, the selected services will be rescheduled. We encourage your frank discussion of these matters with your funeral director, and we will attempt to assist you in any way possible.

Payment Options

- Payment with cash or check (\$35.00 Fee for a returned check).
- Payment with an approved Visa or MasterCard
- Assignment of Insurance Proceeds (Financed by C & J Financial, LLC). Assignment of non-contestable insurance policies can be financed through certain institutions as long as a known cause of death is listed on the Death Certificate. The Financing Company usually charges a fee of up to 5% of amount assigned. As an accommodation to the family, the Financing Company will make the funeral/cemetery expense payment directly to the mortuary usually within 7 to 10 working days after all information is verified and received.

This fee is determined by the California State Department of Consumer Affairs to be necessary for providing fees for regulation enforcement. As of January 1, 2023, this fee is applicable and has been approved by the State legislature
