Scholarship Application Requirements

1. The applicant must be a **member in good standing of Friendly Federal Credit Union for at least 6 months prior to submitting a scholarship application.**
2. The applicant must demonstrate the ability to successfully complete a 2- year associate, a 4 year- undergraduate degree program at an accredited college, university, **or full-time career preparatory program at an accredited technical or trade school** (such as New Castle School of Trades, Pittsburgh Technical College, etc.) This is shown by achieving a cumulative grade point average (**GPA**) **of at least 3.0** as reflected on a school transcripts.
3. The applicant must have participated in **extra-curricular activities** (can include part-time employment). Please provide a description of the activity.
4. The applicant must have participated in **community service** that exemplifies the spirit of good citizenship.
5. The applicant must submit a **typed essay of 1,000 to 1,500 words on the topic: "Why I value my Credit Union."**
6. The applicant must attach the following to the application form:
 - **A copy of high school or college transcript (no official seal is required)**
 - **A copy of the acceptance letter from the accredited college, university, or trade/technical school that the applicant plans to attend. In the case of the enrolled student, a copy of the course schedule for the upcoming year is sufficient.**
 - **A typed 1,000-1,500-word essay on the topic noted above.**
 - **A typed list of extra-curricular activities and community service**
7. In the event of a tie, the deciding factor will be the applicant's community service participation.
8. Scholarship **funds are to be used only for the recipient's tuition, books, and other related school expenses.**
9. Scholarship recipients are eligible to reapply for scholarship awards each year that they enrolled in an accredited college, university, or trade/technical school. **Applications should be updated each year by including a current grade report (does not need an official seal). Essays should be updated to reflect new understandings or perspectives on the value of the credit union.**
10. Immediate family members of any individual member of the Board of Directors/Committee, or employee of Friendly Federal Credit Union are not eligible to apply.
11. All applications and required attachments must be received **by June 28**, and sent via US mail, or dropped off at Friendly Federal Credit Union office.
