Introductions: SCEDD Executive Director, Sharon Hueftle; SCEDD Deputy Director, LeAnn Jochum; Gibbon City Administrator, Matt Smallcomb.

The agenda for this meeting was approved by unanimous vote. Ed Dexter made the motion; Marni Danhauer provided the second.

The **consent agenda** for this meeting was approved by a unanimous roll call vote following a motion by Marni Danhauer and second by Laura Berthelsen. Consent agenda included:

Public Comment: Matt Smallcomb discussed the community center project – this will hold the City Offices also. He shared about a park project (foundation grant of \$200,000 was received), and he gave kudos to Lori for assistance with the Downtown Revitalization planning grant.

Hueftle updated the Board that the FCC Affordable Connectivity Program (ACP) program, and consequently the grant funding to promote it, is abruptly ending February 7, 2024 per notice from the FCC. SCEDD will no longer be promoting the program.

Hueftle provided a **Project Status Report**: SCEDD has submitted a revised grant application for Broadband Tech Assistance; Franklin, Osceola, and Red Cloud have completed nuisance abatement for the year and Glenvil is nearly complete, with one garage to demo. SCEDD was awarded the Nebraska Environmental Trust grant for \$398K for Small Town Recovery and Resilience; this project will be implemented in Stamford, Upland and Franklin. SCEDD will be conducting a CNAS and Housing Study in Stamford. An overview of the status of business and housing loans was provided.

Discussion/Action Items:

Following a review of the Income Statement and Balance Sheet, Joe Patterson moved to accept for filing the **12/31/2023 Financial Reports** as presented, Gene Horne seconded the motion; roll call vote provided unanimous approval.

Hueftle reviewed the investment reports. Chris Schluntz made a motion to accept for filing the **12/31/2023 Investment Reports** for 2017/2020 and 2022 Rural Workforce Housing, and Community Catalyst funds, Ed Dexter seconded the motion; roll call vote provided unanimous approval.

Conflict of Interest: Hueftle reviewed the Conflict-of-Interest policy with the Board. Board members that were present completed their forms.

Bonding Fiscal Officer and Executive Director: Hueftle asked the board to consider bonding SCEDD's Fiscal Officer and Executive Director. It was determined that more discussion and research was needed before a decision could be made. The topic will be revisited at the March Board Meeting.

Hueftle informed the Board that SCEDD was awarded the **Nebraska Environmental Trust Grant** for \$398,000 for Small Towns Achieving Recovery and Resilience. Jochum went over the scope of services provided through the grant, SCEDD will assist Franklin, Stamford and Upland in the demolition and cleanup of vacant dilapidated parcels; the Nuisance Abatement Program may be utilized. Hueftle reminded the board that SCEDD committed \$40,000 in matching funds for this grant.

Marni Danhauer moved to adjourn the meeting. Linda Glause seconded the motion. **The meeting was adjourned at 6:56PM**; unanimous approval.
