Accessibility Arrangements – A. Kriel & Co. – Advocates and Legal Consultants

Building accessibility arrangements in the Firm's different offices:

Tel Aviv - 28 Ha'arbaa, Northern Tower

- The entrance to the offices on the fourth floor is completely accessible.
- The Firm's parking lot includes disabled parking spaces with access to direct elevators to the floors.

In addition, at the building's front, there are two designated disabled parking spaces.

• The accessible toilets are located at Entrance B, Floor 3.

Modi'in - Dona 1, 38 Dam Hamaccabim St.

- There is a reserved disabled parking space at 38 Dam Hamaccabim St
- From the parking, the elevators to the street floors are accessible.
- Toilets there are accessible toilets on the office floor.
- The offices are accessible by an elevator that reaches the floor directly, and it is possible to enter the door with a wheelchair.

Website accessibility

An accessible website is a website that allows persons with disabilities and seniors to use it on the same level of efficiency and enjoyment as all other visitors. Approximately 20%-25% of the population face difficulties in using the internet and could benefit from more accessible internet content, according to a study conducted by Microsoft in 2003.
