Resident, John Soininen is concerned about the seasonal camp on Wood Hill Road. Apparently, the owner is living there with no septic or running water and the area is a mess. He thought when a subdivision was made the property needed to be brought into compliance with having septic and water. Denis brought up an ad on Front Porch Forum you could purchase a small shed and set it up on land on Route 5 with the possibility of owning your own property. Estelle Simpson's daughter did this or tried to do this on someone else's property and Patti warned her about building on someone else's property.

Shane said we also have a junk car on Sheffield Road, which is an issue. Tim and Denis both said Joe Witt needs to be contacted since he is the zoning administrator to deal with these issues. If Joe cannot get something done, we will issue citations. Patti said that Joe is aware of this but not sure if he has been up there or not.

Matt Heighton was on the agenda but did not come to the meeting.

DRB member Robert Simms presented an outline to the Select Board about a new Town of Sutton Zoning District Map for the future drawn up by NVDA to deal with the new enacted legislation for Act 181 dealing with the housing shortages throughout the state. Rob wanted to introduce the subject today and how we think it will affect our town. Tonight, he is seeking information only and would like the select board members' advice or try to answer questions. After hearing and reviewing the information presented, the board members stated to let NVDA know we will keep the existing zoning map. Rob said he will take that to NVDA and get back to the board members.
